HOUSE BILL NO. 167 (As Passed the House)

1 AN ACT TO AMEND SECTION 65-3-97, MISSISSIPPI CODE OF 1972, TO ADD A SEGMENT OF HIGHWAY IN JACKSON COUNTY TO THE FOUR-LANE HIGHWAY PROGRAM; AND FOR RELATED PURPOSES. 2 3

- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 4
- SECTION 1. Section 65-3-97, Mississippi Code of 1972, is 5
- 6 amended as follows:
- 7 65-3-97. (1) In addition to and including all other
- 8 highways designated as a part of the state highway system, there
- 9 is hereby designated as a part thereof a four-lane highway system
- to connect various areas of the state with interstate and primary 10
- highways. The Mississippi Department of Transportation shall 11
- 12 construct and reconstruct four-lane highways, that is, not less
- 13 than two (2) lanes for traffic flowing in each direction, along
- the routes designated in this section. 14
- (2) In the construction and reconstruction of the four-lane 15
- highway system designated in this section, the Mississippi 16
- Department of Transportation may utilize the roadway of any 17
- existing highway under its jurisdiction and control and shall do 18
- so when such utilization is feasible, provided that such highways 19
- 20 which are utilized shall be constructed to current standards for
- such roadways. When it is not feasible to utilize existing 21
- 22 designated highways, the Transportation Department shall relocate
- such highways and construct entirely new facilities whether in 23
- urban or rural areas. 24
- (3) Construction of the four-lane highway system designated 25
- 26 in this subsection shall commence, proceed and be performed by the

- 27 Mississippi Department of Transportation strictly in accordance
- 28 with the following set of priorities established for the letting
- 29 of contracts on and along various segments thereof:
- 30 (a) Of the following group of highway segments not less
- 31 than fifteen percent (15%) of all contracts necessary to be let
- 32 for completion of all segments within the group shall be let by
- 33 June 30, 1988, not less than thirty percent (30%) of such
- 34 contracts shall be let by June 30, 1989, not less than fifty
- 35 percent (50%) of such contracts shall be let by June 30, 1990, not
- 36 less than seventy percent (70%) of such contracts shall be let by
- 37 June 30, 1991, not less than ninety percent (90%) of such
- 38 contracts shall be let by June 30, 1992, and one hundred percent
- 39 (100%) of such contracts shall be let by June 30, 1993:
- 40 (i) Highway segments along or near U.S. 45
- 41 beginning at the Clarke/Lauderdale county line and extending
- 42 northerly to I-59; then beginning at Macon and extending northerly
- 43 to Brooksville; then beginning at Columbus Air Force Base and
- 44 extending northerly to Aberdeen; then beginning at U.S. 278 and
- 45 extending northerly to Shannon; then beginning at Saltillo and
- 46 extending northerly to Corinth.
- 47 (ii) Highway segments along or near U.S. 45A
- 48 beginning at U.S. 82 and extending northerly to West Point; then
- 49 beginning four (4) miles south of Okolona and extending northerly
- 50 to Shannon.
- 51 (iii) A highway segment along or near U.S. 49W
- 52 beginning at U.S. 49 and extending westerly through Yazoo City to
- 53 the Yazoo River.
- (iv) A highway segment along or near U.S. 49W
- 55 beginning at Inverness and extending northerly to Indianola.
- 56 (v) A highway segment along or near U.S. 61
- 57 beginning at Port Gibson and extending northerly to the four-lane
- 58 south of Vicksburg.
- (vi) Highway segments along or near U.S. 72
- 60 beginning at or near Mt. Pleasant and extending southeasterly to
- 61 Mississippi 5; then beginning at Walnut and extending
- 62 southeasterly to Corinth; then beginning at Strickland and
- 63 extending southeasterly to Burnsville.

- 88 shall be let by June 30, 1995, not less than seventy percent (70%)
- 89 of such contracts shall be let by June 30, 1996, not less than
- 90 eighty-five percent (85%) of such contracts shall be let by June
- 91 30, 1997, and one hundred percent (100%) of such contracts shall

- 116 (vii) A highway segment along or near U.S. 49W
- 117 beginning at the Yazoo River and extending northerly to Inverness.

- 119 beginning at the Louisiana state line and extending northerly to

- 200 northwesterly to Kosciusko.
- F. Highway segments along or near Mississippi
- 202 25 beginning at Aberdeen and extending northerly to Fulton; then
- 203 beginning at the Alabama state line and extending northerly to
- 204 U.S. Highway 72.
- G. A highway segment along or near U.S.
- 206 Highway 61 beginning at Redwood and extending northerly to Leland.
- 207 H. A highway segment along or near U.S.
- 208 Highway 98 beginning at Meadville and extending southeasterly to
- 209 Summit or, in lieu thereof, a highway segment along or near
- 210 Mississippi Highway 24/48 beginning at Woodville and extending
- 211 easterly to McComb, whichever of such routes meets the criteria
- 212 established in subparagraph (d)(ii) of this subsection (3).
- I. A highway segment along or near
- 214 Mississippi 35 beginning at the Mississippi/Louisiana state line
- 215 and extending northerly to or near Foxworth.
- J. A highway segment along or near
- 217 Mississippi 27 beginning at I-20 and extending southeasterly to
- 218 I-55.
- 219 <u>K. A highway segment along or near</u>
- 220 <u>Mississippi 57 beginning at I-10 and extending northerly ten (10)</u>
- 221 miles to just north of the community of Van Cleave.
- 222 (ii) Contracts for the construction and/or
- 223 reconstruction of highway segments designated within this group
- 224 shall be let by the Transportation Commission strictly in
- 225 accordance with the volume capacity of the highway segment. If
- 226 the volume capacity of a highway segment is less than the volume
- 227 capacity threshold at which the Transportation Department
- 228 recommends the construction of a four-lane highway, then the

229 Transportation Department shall make other improvements and

230 highway modifications to such highway segment as needed, such as

- 231 straightening and realignment of the existing roadway, the
- 232 addition of passing lanes and the widening of existing lanes, and
- 233 may acquire any necessary right-of-way for such purposes and for
- 234 the purpose of future construction of four-lane highways along
- 235 such segments.
- 236 (4) The construction priorities established in this section
- 237 shall not be construed as prohibiting the completion of highway
- 238 segments which, on July 1, 1987, are included in the current
- 239 three-year plan under Section 65-1-141, and for which, on July 1,
- 240 1987, grade and drainage has been completed or contracts for grade
- 241 and drainage have been let.
- 242 (5) Contracts may be let and construction may commence and
- 243 be performed concurrently on any of the highway segments
- 244 designated in subsection (3) of this section, notwithstanding the
- 245 priorities established for the letting of contracts on the various
- 246 segments designated therein, provided that funds are available
- 247 and, provided that, at all times, the percentages of all contracts
- 248 required to be let on the segments designated in paragraphs
- 249 (3)(a), (3)(b), (3)(c) and (3)(d), respectively, are, in fact, let
- 250 no later than the dates established therein.
- 251 (6) (a) All highway construction and reconstruction
- 252 authorized under this section shall be performed by contract let
- 253 on competitive bid in the manner provided by statute; however,
- 254 highway segments shall be constructed in lengths of not less than
- 255 ten (10) miles.
- 256 (b) It is the intent of the Legislature that not less
- 257 than ten percent (10%) of the amounts authorized to be expended
- 258 for construction and reconstruction of the four-lane highway
- 259 segments designated in this section shall be expended with small
- 260 business concerns owned and controlled by socially and
- 261 economically disadvantaged individuals. The term "socially and

- 262 economically disadvantaged individuals" shall have the meaning
- 263 ascribed to such term under Section 8(d) of the Small Business Act
- 264 (15 USCS, Section 637(d)) and relevant subcontracting regulations
- 265 promulgated pursuant thereto; except that women shall be presumed
- 266 to be socially and economically disadvantaged individuals for the
- 267 purposes of this paragraph (b).
- 268 (7) (a) Notwithstanding the provisions of subsection (6)(a)
- 269 of this section, the Mississippi Transportation Commission may
- 270 construct highway segments of less than ten (10) miles in length
- 271 if:
- 272 (i) The segment as described in subsection (3) of
- 273 this section is less than ten (10) miles in length;
- 274 (ii) The segment will connect two (2) existing
- 275 four-lane highways;
- 276 (iii) The segment will connect an existing
- 277 four-lane highway with an incorporated municipality;
- 278 (iv) The segment will connect an existing
- 279 four-lane highway with a river, the state boundary or any other
- 280 natural or man-made barrier;
- 281 (v) For a particular project, the costs of
- 282 constructing a single segment of at least ten (10) miles in length
- 283 would greatly exceed the aggregate costs of constructing two (2)
- 284 or more segments; or
- 285 (vi) The segment is in an urban area and involves
- 286 the completion of bypasses or other construction which will
- 287 facilitate and accommodate major traffic movement.
- 288 (b) In any case in which the Transportation Commission
- 289 authorizes the construction of a highway segment of less than ten
- 290 (10) miles in length, the commission shall set forth and record in
- 291 its official minutes explanation and justification therefor based
- 292 upon one or more of the conditions prescribed in paragraph (7)(a)
- 293 of this section.
- 294 (8) To assist in defraying the costs and expenses for

- 295 construction, reconstruction and relocation of the four-lane
- 296 highway system described in this section, the following revenues
- 297 shall be paid out of such funds made available to the
- 298 Transportation Commission and the Transportation Department:
- 299 (a) From matched federal funds or other federal funds,
- 300 Thirty-two Million Dollars (\$32,000,000.00) for fiscal year 1988,
- 301 Twenty-five Million Dollars (\$25,000,000.00) for fiscal year 1989,
- 302 Thirty Million Dollars (\$30,000,000.00) for fiscal year 1990 and
- 303 fifty percent (50%) of such federal funds for fiscal year 1991 and
- 304 each fiscal year thereafter; and
- 305 (b) Five Million Dollars (\$5,000,000.00) from matched
- 306 federal bridge replacement funds for fiscal year 1988 and each
- 307 fiscal year thereafter when the segments proposed for construction
- 308 contain bridges that are eligible for replacement under the
- 309 Federal Aid Bridge Replacement Program.
- 310 (9) The Transportation Department shall submit a report to
- 311 the Legislature by January 10 of each calendar year setting forth
- 312 the current status of the construction program set forth in this
- 313 section to include, but not be limited to, the following
- 314 information:
- 315 (a) Specific segments on which engineering is being
- 316 performed or has been completed;
- 317 (b) Specific segments for which right-of-way has been
- 318 acquired or is being acquired;
- 319 (c) Specific segments for which construction contracts
- 320 have been let;
- 321 (d) Specific segments on which construction is in
- 322 progress;
- 323 (e) Specific segments on which construction has been
- 324 completed;
- 325 (f) Projections for completion of the next step on each
- 326 segment;
- 327 (g) Revenue derived for such construction program from

- 328 each revenue source contained in Chapter 322, Laws, 1987, and in
- 329 <u>Chapter 557</u>, <u>Laws</u>, 1994;
- 330 (h) For each fiscal year beginning in 1994, a detailed
- 331 cash flow projection by source of program activities and an
- 332 estimate of when the program will encounter a funding shortage due
- 333 to costs exceeding original projections;
- 334 (i) A schedule of all complete and open-to-traffic
- 335 highway segments and the related total cost of each segment;
- 336 (j) A schedule of all highway segments on which all
- 337 contracts necessary for completion of the segments were not let as
- 338 of the date required by law;
- (k) A complete recap of all program receipts by source,
- 340 and of all disbursements for the prior fiscal year and cumulative
- 341 totals since the inception of the program as compared to
- 342 projections; and
- 343 (1) A statement from the Department of Transportation
- 344 regarding the status of the funding of the program based on agency
- 345 cost experience and projections for the future.
- 346 The report shall be deemed submitted when ten (10) copies are
- 347 submitted to the Clerk of the House of Representatives and ten
- 348 (10) copies are submitted to the Secretary of the Senate.
- 349 SECTION 2. This act shall take effect and be in force from
- 350 and after its passage.
