HOUSE BILL NO. 261

1	AN ACT TO AMEND SECTION 97-37-1, MISSISSIPPI CODE OF 1972, TO
2	PROVIDE THAT IT SHALL BE A FELONY FOR THE ILLEGAL CARRYING OF A
3	DEADLY WEAPON IF THE OFFENSE OCCURS ON ANY PREMISES LICENSED TO
4	SELL OR SERVE ALCOHOLIC BEVERAGES, BEER OR LIGHT WINE AND TO
5	PROVIDE PENALTIES THEREFOR; AND FOR RELATED PURPOSES.

- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 7 SECTION 1. Section 97-37-1, Mississippi Code of 1972, is
- 8 amended as follows:
- 9 97-37-1. (1) Except as otherwise provided in Section
- 10 45-9-101, any person who carries, concealed in whole or in part,
- 11 any bowie knife, dirk knife, butcher knife, switchblade knife,
- 12 metallic knuckles, blackjack, slingshot, pistol, revolver, or any
- 13 rifle with a barrel of less than sixteen (16) inches in length, or
- 14 any shotgun with a barrel of less than eighteen (18) inches in
- 15 length, machine gun or any fully automatic firearm or deadly
- 16 weapon, or any muffler or silencer for any firearm, whether or not
- 17 it is accompanied by a firearm, or uses or attempts to use against
- 18 another person any imitation firearm, shall upon conviction be
- 19 punished as follows:
- 20 (a) By a fine of not less than One Hundred Dollars
- 21 (\$100.00) nor more than Five Hundred Dollars (\$500.00), or by
- 22 imprisonment in the county jail for not more than six (6) months,
- 23 or both, in the discretion of the court, for the first conviction
- 24 under this section.
- 25 (b) By a fine of not less than One Hundred Dollars
- 26 (\$100.00) nor more than Five Hundred Dollars (\$500.00), and
- 27 imprisonment in the county jail for not less than thirty (30) days

- 28 nor more than six (6) months, for the second conviction under this
- 29 section.
- 30 (c) By imprisonment in the State Penitentiary for not
- 31 less than one (1) year nor more than five (5) years, for the third
- 32 or more convictions under this section.
- 33 (d) By imprisonment in the State Penitentiary for not
- 34 less than one (1) year nor more than five (5) years for any person
- 35 previously convicted of any felony who is convicted under this
- 36 section.
- 37 <u>(e) By imprisonment in the State Penitentiary for not</u>
- 38 less than two (2) years, nor more than ten (10) years, and by a
- 39 fine not to exceed Five Thousand Dollars (\$5,000.00), for any
- 40 person convicted under this section if the offense occurs on any
- 41 premises licensed or issued a permit under Title 67, Mississippi
- 42 Code of 1972, for the sale or service of alcoholic beverages, beer
- 43 or light wine. A violation of this paragraph shall be a felony.
- 44 (2) It shall not be a violation of this section for any
- 45 person over the age of eighteen (18) years to carry a firearm or
- 46 deadly weapon concealed in whole or in part within the confines of
- 47 his own home or his place of business, or any real property
- 48 associated with his home or business or within any motor vehicle.
- 49 (3) It shall not be a violation of this section for any
- 50 person to carry a firearm or deadly weapon concealed in whole or
- 51 in part if the possessor of the weapon is then engaged in a
- 52 legitimate weapon-related sports activity or is going to or
- 53 returning from such activity. For purposes of this subsection,
- "legitimate weapon-related sports activity" means hunting,
- 55 fishing, target shooting or any other legal sports activity which
- 56 normally involves the use of a firearm or other weapon.
- 57 SECTION 2. This act shall take effect and be in force from
- 58 and after its passage.
