HOUSE BILL NO. 343

1 AN ACT MAKING AN APPROPRIATION TO THE MISSISSIPPI NATIONAL
2 GUARD FOR CONSTRUCTION OF A NEW ARMORY AT VICKSBURG, MISSISSIPPI,
3 AND BROOKHAVEN, MISSISSIPPI, FOR FISCAL YEAR 2000.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

5 SECTION 1. The following sum, or so much thereof as may be
6 necessary, is appropriated out of any money in the State General
7 Fund not otherwise appropriated, to the Mississippi National Guard
8 for the purpose of constructing a new armory at Vicksburg,
9 Mississippi, and to authorize the use of part of the funds to
10 match any federal funds that may be available to the State for
11 armory construction, for the fiscal year beginning July 1, 1999,
12 and ending June 30, 2000..... \$1,552,000.00.

13 SECTION 2. The following sum, or so much there of as may be
14 necessary, is appropriated out of any money in the State General
15 Fund not otherwise appropriated, to the Mississippi National Guard
16 for the purpose of constructing a new armory at Brookhaven,
17 Mississippi, and to authorize the use of part of such funds to
18 match any federal funds that may be available to the State for
19 armory construction, for the fiscal year beginning July 1, 1999,
20 and ending June 30, 2000..... \$1,100,000.00.

21 SECTION 3. The acceptance and expenditure of federal
22 government funds which may become available to the Mississippi
23 National Guard for construction purposes is authorized and
24 approved, provided the receipts and expenditures are reported and
25 otherwise handled in accordance with the State budget law, which
26 is Section 27-103-101 et seq. and Section 27-104-1 et seq.,

27 Mississippi Code of 1972.

28 SECTION 4. The following sum, or so much thereof as may be
29 necessary, is appropriated out of any money in the special fund in
30 the State Treasury to the credit of the Mississippi National
31 guard, for the purpose of carrying out the provisions of
32 applicable statutes and Federal/State construction agreements for
33 the fiscal year beginning July 1, 1999, and ending June 30,
34 2000..... \$9,593,000.00.

35 SECTION 5. It is the intention of the Legislature that the
36 Adjutant General may transfer excess funds among the armory
37 construction projects set forth in Section 1 and Section 2.

38 SECTION 6. The money appropriated under the provisions of
39 Section 1 and Section 2 shall be paid by the State Treasurer out
40 of any money in the State General Fund not otherwise appropriated,
41 and the money appropriated under the provisions of Section 4 shall
42 be paid by the State treasurer out of the special fund to the
43 credit of the Mississippi National Guard, upon warrants issued by
44 the State Fiscal Officer; and the State Fiscal Officer shall issue
45 his warrants upon requisitions signed by the proper person,
46 officer or officers in the manner provided by law.

47 SECTION 7. This act shall take effect and be in force from
48 and after July 1, 1999.
