HOUSE BILL NO. 609 (As Sent to Governor)

1 AN ACT TO AMEND SECTION 41-79-5, MISSISSIPPI CODE OF 1972, TO 2 EXTEND THE DATE OF THE REPEALER ON THE PROVISION THAT ALLOWS LOCAL 3 SCHOOL DISTRICTS TO RECEIVE STATE MATCHING FUNDS FOR SCHOOL NURSE INTERVENTION PROGRAMS; AND FOR RELATED PURPOSES. 4 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 6 SECTION 1. Section 41-79-5, Mississippi Code of 1972, is 7 amended as follows: 8 41-79-5. (1) There is hereby established within the State Department of Health a school nurse intervention program, 9 10 available to all public school districts in the state. (2) By the school year 1998-1999, each public school 11 12 district shall have employed a school nurse, to be known as a Health Service Coordinator, pursuant to the school nurse 13 intervention program prescribed under this section. The school 14 15 nurse intervention program shall offer any of the following specific preventive services, and other additional services 16 17 appropriate to each grade level and the age and maturity of the pupils: 18 Reproductive health education and referral to 19 (a) 20 prevent teen pregnancy and sexually transmitted diseases, which education shall include abstinence; 21 (b) Child abuse and neglect identification; 2.2 23 (c) Hearing and vision screening to detect problems 24 which can lead to serious sensory losses and behavioral and 25 academic problems;

26 (d) Alcohol, tobacco and drug abuse education to reduce27 abuse of these substances;

28 (e) Scoliosis screening to detect this condition so 29 that costly and painful surgery and lifelong disability can be 30 prevented;

Coordination of services for handicapped children 31 (f) 32 to ensure that these children receive appropriate medical 33 assistance and are able to remain in public school;

34 (g) Nutrition education and counseling to prevent obesity and/or other eating disorders which may lead to 35 life-threatening conditions, for example, hypertension; 36

37 Early detection and treatment of head lice to (h) prevent the spread of the parasite and to reduce absenteeism; 38

(i) Emergency treatment of injury and illness to 40 include controlling bleeding, managing fractures, bruises or 41 contusions and cardiopulmonary resuscitation (CPR);

Applying appropriate theory as the basis for 42 (j) 43 decision making in nursing practice;

44 (k) Establishing and maintaining a comprehensive school 45 health program;

Developing individualized health plans; (1)

47 Assessing, planning, implementing and evaluating (m) 48 programs and other school health activities, in collaboration with other professionals; 49

50 (n) Providing health education to assist students, families and groups to achieve optimal levels of wellness; 51

52 (o) Participating in peer review and other means of 53 evaluation to assure quality of nursing care provided for students and assuming responsibility for continuing education and 54 professional development for self while contributing to the 55 professional growth of others; 56

57 Participating with other key members of the (p) 58 community responsible for assessing, planning, implementing and evaluating school health services and community services that 59 60 include the broad continuum or promotion of primary, secondary and

## 61 tertiary prevention; and

Contributing to nursing and school health through 62 (a) 63 innovations in theory and practice and participation in research. (3) Public school nurses shall be specifically prohibited 64 65 from providing abortion counseling to any student or referring any student to abortion counseling or abortion clinics. Any violation 66 67 of this subsection shall disqualify the school district employing such public school nurse from receiving any state administered 68 69 funds under this section.

70 (4) Each local school district of this state may apply for a school nurse intervention program. State administered funds shall 71 72 only be available on a 50-50 matching basis, and subject to 73 appropriation by the Legislature, with the local school district 74 providing its local contribution from nonminimum program funds. 75 However, school districts with an ad valorem assessed value per 76 student of less than Seventeen Thousand Dollars (\$17,000.00), 77 according to the most recent ad valorem assessed valuation, shall not be required to make a local contribution to the cost of the 78 79 In order to be eligible for such program, each district program. 80 desiring to participate shall apply to the State Department of 81 Health by May 31 before the beginning of the applicable fiscal year. Such applications shall be on forms provided by the State 82 83 Department of Health. The local school governing board and the county health department shall mutually determine their school 84 85 nurse intervention program within the previously determined state 86 guidelines. The State Department of Health shall determine by 87 July 1 of each succeeding year which local school districts have 88 submitted approved applications for school nurse intervention This subsection (4) shall stand repealed on July 1, 89 programs. 90 2000.

91 (5) Beginning with the 1997-1998 school year, to the extent 92 that federal or state funds are available therefor and pursuant to 93 appropriation therefor by the Legislature, in addition to the

94 school nurse intervention program funds administered under 95 subsection (4), the State Department of Health shall establish and implement a Prevention of Teen Pregnancy Pilot Program to be 96 97 located in the public school districts with the highest numbers of teen pregnancies. The Teen Pregnancy Pilot Program shall provide 98 99 the following education services directly through public school nurses in the pilot school districts: health education sessions 100 in local schools, where contracted for or invited to provide, 101 102 which target issues including reproductive health, teen pregnancy 103 prevention and sexually transmitted diseases, including syphilis, 104 HIV and AIDS. When these services are provided by a school nurse, 105 training and counseling on abstinence shall be included.

106 In addition to the school nurse intervention program (6) 107 funds administered under subsection (4) and the Teen Pregnancy Pilot Program funds administered under subsection (5), to the 108 109 extent that federal or state funds are available therefor and 110 pursuant to appropriation therefor by the Legislature, the State 111 Department of Health shall establish and implement an Abstinence 112 Education Pilot Program to provide abstinence education, 113 mentoring, counseling and adult supervision to promote abstinence 114 from sexual activity, with a focus on those groups which are most likely to bear children out-of-wedlock. Such abstinence education 115 116 services shall be provided by the State Department of Health 117 through its clinics, public health nurses, school nurses and 118 through contracts with rural and community health centers in order 119 to reach a larger number of targeted clients. For purposes of 120 this subsection, the term "abstinence education" means an 121 educational or motivational program which:

(a) Has as its exclusive purpose, teaching the social,
psychological and health gains to be realized by abstaining from
sexual activity;

125 (b) Teaches abstinence from sexual activity outside126 marriage as the expected standard for all school-age children;

127 (c) Teaches that abstinence from sexual activity is the 128 only certain way to avoid out-of-wedlock pregnancy, sexually 129 transmitted diseases and other associated health problems;

130 (d) Teaches that a mutually faithful monogamous
131 relationship in context of marriage is the expected standard of
132 human sexual activity;

(e) Teaches that sexual activity outside of the context of marriage is likely to have harmful psychological and physical effects;

(f) Teaches that bearing children out of wedlock is likely to have harmful consequences for the child, the child's parents and society;

(g) Teaches young people how to reject sexual advances and how alcohol and drug use increase vulnerability to sexual advances; and

142 (h) Teaches the importance of attaining143 self-sufficiency before engaging in sexual activity.

(7) Beginning with the 1998-1999 school year and pursuant to 144 145 appropriation therefor by the Legislature, in addition to other funds allotted under the minimum education program, each school 146 147 district shall be allotted an additional teacher unit per every one hundred (100) teacher units, for the purpose of employing 148 149 qualified public school nurses in such school district, which in 150 no event shall be less than one (1) teacher unit per school district, for such purpose. In the event the Legislature provides 151 152 less funds than the total state funds needed for the public school nurse allotment, those school districts with fewer teacher units 153 154 shall be the first funded for such purpose, to the extent of funds 155 available.

156 (8) Prior to the 1998-1999 school year, nursing staff
157 assigned to the program shall be employed through the local county
158 health department and shall be subject to the supervision of the
159 State Department of Health with input from local school officials.

160 Local county health departments may contract with any 161 comprehensive private primary health care facilities within their 162 county to employ and utilize additional nursing staff. Beginning with the 1998-1999 school year, nursing staff assigned to the 163 164 program shall be employed by the local school district and shall 165 be designated as "health service coordinators," and shall be 166 required to possess a bachelor's degree in nursing as a minimum 167 qualification.

(9) Upon each student's enrollment, the parent or guardian 168 169 shall be provided with information regarding the scope of the 170 school nurse intervention program. The parent or guardian may 171 provide the school administration with a written statement 172 refusing all or any part of the nursing service. No child shall 173 be required to undergo hearing and vision or scoliosis screening or any other physical examination or tests whose parent objects 174 175 thereto on the grounds such screening, physical examination or 176 tests are contrary to his sincerely held religious beliefs.

(10) A consent form for reproductive health education shall 177 178 be sent to the parent or guardian of each student upon his 179 enrollment. If a response from the parent or guardian is not 180 received within seven (7) days after the consent form is sent, the school shall send a letter to the student's home notifying the 181 182 parent or guardian of the consent form. If the parent or guardian 183 fails to respond to the letter within ten (10) days after it is sent, then the school principal shall be authorized to allow the 184 185 student to receive reproductive health education. Reproductive health education shall include the teaching of total abstinence 186 from premarital sex and, wherever practicable, reproductive health 187 education should be taught in classes divided according to gender. 188 189 All materials used in the reproductive health education program 190 shall be placed in a convenient and easily accessible location for 191 parental inspection. School nurses shall not dispense birth 192 control pills or contraceptive devices in the school. Dispensing

193 of such shall be the responsibility of the State Department of 194 Health on a referral basis only.

(11) No provision of this section shall be construed as prohibiting local school districts from accepting financial assistance of any type from the State of Mississippi or any other governmental entity, or any contribution, donation, gift, decree or bequest from any source which may be utilized for the maintenance or implementation of a school nurse intervention program in a public school system of this state.

202 SECTION 2. This act shall take effect and be in force from 203 and after July 1, 1999.
