HOUSE BILL NO. 740 (As Passed the House)

1 AN ACT TO AMEND SECTION 43-1-28, MISSISSIPPI CODE OF 1972, TO 2 DELAY THE DEADLINES FOR THE DEPARTMENT OF HUMAN SERVICES TO 3 DEVELOP AND IMPLEMENT AN ON-LINE ELECTRONIC BENEFIT TRANSFER (EBT) 4 SYSTEM FOR FOOD STAMPS; AND FOR RELATED PURPOSES.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 6 SECTION 1. Section 43-1-28, Mississippi Code of 1972, is 7 amended as follows:

43-1-28. (1) The Department of Human Services shall develop 8 an on-line electronic benefit transfer (EBT) system for the food 9 10 stamp program in Mississippi as an alternative to issuing food stamp coupons. The EBT system developed by the department under 11 12 this section shall (a) provide that food stamp benefits are stored 13 in and issued from a central computer data base and are electronically accessed by households at the point of sale through 14 15 the use of reusable magnetic-stripe plastic cards; and (b) meet all requirements and standards specified in 7 USCS Section 2016(i) 16 17 and the rules and regulations issued under that provision for approval by the Secretary of the United States Department of 18 19 Agriculture.

20 (2) The department shall finish development of the EBT system no later than October 1, 2000, and shall submit an 21 22 application to the Secretary of the United States Department of 23 Agriculture for approval of the system. After the EBT system has 24 been approved, the department shall implement and operate the 25 system as a pilot project in not less than five (5) counties 26 selected by the department, which counties shall represent the different geographical areas, population levels and economic 27

After the pilot project has been evaluated and approved by the United States Department of Agriculture, and subject to the availability of funds specifically appropriated therefor, the system may be expanded statewide at a rate determined by the Executive Director of the Department of Human Services. The system shall be expanded and implemented statewide not later than October 1, 2001.

35 (3) The department shall seek to obtain the maximum amount 36 of federal financial participation available to fund the cost of 37 administering the EBT system.

(4) The Department of Human Services may develop an on-line 38 electronic benefit transfer (EBT) system for the Temporary 39 40 Assistance for Needy Families (TANF) program in Mississippi as an alternative to issuing cash or voucher payments. The EBT system 41 developed by the department under this section shall (a) provide 42 that TANF benefits are stored in and issued from a central 43 44 computer data base and are electronically accessed; and (b) meet 45 all requirements and standards specified in the Personal Responsibility and Work Opportunity Reconciliation Act of 1996 46 47 (Public Law 104-193), and the rules and regulations issued under that act. The department shall seek to obtain the maximum amount 48 49 of federal financial participation available to fund the cost of administering the EBT system for TANF payments. 50

51 SECTION 2. This act shall take effect and be in force from 52 and after July 1, 1999.
