1	AND HIGHERY TO MAKE A COMPRESSION TO THE DEPARTMENT OF ARCHIVES
2 3	AND HISTORY TO MAKE A CONTRIBUTION TO THE WOMEN IN MILITARY SERVICE FOR AMERICA MEMORIAL FOUNDATION FOR THE PURPOSE OF
4	CONTRIBUTING TO THE COMPLETION OF THE NATIONAL MEMORIAL TO HONOR
5	AMERICA'S AND MISSISSIPPI'S SERVICE WOMEN PAST, PRESENT AND FUTURE
6	FOR THE FISCAL YEAR 2000.
7	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
8	SECTION 1. The following sum, or so much of it as may be
9	necessary, is appropriated out of any money in the State General
10	Fund not otherwise appropriated, to <u>the Department of Archives and</u>
11	<u>History to make a contribution to</u> the Women In Military Service
12	For America Memorial Foundation for the purpose of contributing to
13	the completion of the National Memorial to honor America's and
14	Mississippi's Service Women Past, Present and Future for the
15	fiscal year beginning July 1, 1999, and ending June 30,
16	2000\$15,000.00
17	SECTION 2. The money appropriated by this act shall be paid
18	by the State Treasurer out of any money in the State General Fund
19	not otherwise appropriated, upon warrants issued by the State
20	Fiscal Officer; and the State Fiscal Officer shall issue his
21	warrants upon requisitions signed by the proper person, officer or
22	officers in the manner provided by law.

SECTION 3. This act shall take effect and be in force from

24 and after July 1, 1999.
