COMMITTEE SUBSTITUTE FOR HOUSE BILL NO. 820

AN ACT TO AMEND SECTION 37-1-3, MISSISSIPPI CODE OF 1972, TO REQUIRE THE STATE BOARD OF EDUCATION TO DEVELOP OBJECTIVES FOR 1 2 3 EXISTING SECONDARY LEVEL COURSES WHICH FOCUS ON INSTRUCTION IN PERSONAL MONEY MANAGEMENT SKILLS; AND FOR RELATED PURPOSES. 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 5 6 SECTION 1. Section 37-1-3, Mississippi Code of 1972, is 7 amended as follows: 37-1-3. (1) The State Board of Education shall adopt rules 8 9 and regulations and set standards and policies for the 10 organization, operation, management, planning, budgeting and programs of the State Department of Education. 11 (a) The board is directed to identify all functions of 12 13 the department that contribute to or comprise a part of the state system of educational accountability and to establish and maintain 14 within the department the necessary organizational structure, 15 policies and procedures for effectively coordinating such 16 17 functions. Such policies and procedures shall clearly fix and delineate responsibilities for various aspects of the system and 18 19 for overall coordination of the total system and its effective 20 management. (b) The board shall establish and maintain a 21 system-wide plan of performance, policy and directions of public 22 23 education not otherwise provided for. 24 (C) The board shall effectively use the personnel and 25 resources of the department to enhance technical assistance to 26 school districts in instruction and management therein. 27 (d) The board shall establish and maintain a central

The board shall establish and maintain within the 29 (e) 30 State Department of Education a central management capacity under the direction of the State Superintendent of Public Education. 31 32 (f) The board, with recommendations from the superintendent, shall design and maintain a five-year plan and 33 program for educational improvement that shall set forth 34 objectives for system performance and development and be the basis 35 36 for budget requests and legislative initiatives. 37 (2) (a) The State Board of Education shall adopt and maintain a curriculum and a course of study to be used in the 38 39 public schools that is designed to prepare the state's children and youth to be productive, informed, creative citizens, workers 40 and leaders, and it shall regulate all matters arising in the 41 practical administration of the school system not otherwise 42 43 provided for. 44 (b) Before the 1999-2000 school year, the State Board of Education shall develop personal living and finances objectives 45 46 that focus on money management skills for individuals and families 47 for appropriate, existing courses at the secondary level. The 48 objectives must require the teaching of those skills necessary to handle personal business and finances and must include instruction 49 in the following: 50 51 (i) Opening a bank account and assessing the quality of a bank's services; 52 53 (ii) Balancing a check book; 54 (iii) Managing debt, including retail and credit 55 <u>card</u> debt; (iv) Completing a loan application; 56 (v) The implications of an inheritance; 57 58 (vi) The basics of personal insurance policies; (vii) Consumer rights and responsibilities; 59 60 (viii) Dealing with salesmen and merchants;
