## HOUSE BILL NO. 1082

- AN ACT TO AMEND SECTION 39-5-23, MISSISSIPPI CODE OF 1972, TO AUTHORIZE THE MISSISSIPPI DEPARTMENT OF ARCHIVES AND HISTORY TO 3 CREATE THE MISSISSIPPI LANDMARK GRANT PROGRAM WITHIN THE DEPARTMENT'S HISTORIC PROPERTIES TRUST FUND FOR THE PURPOSE OF 5 ENSURING THE PRESERVATION OF PROPERTIES DESIGNATED AS MISSISSIPPI 6 LANDMARKS; TO AUTHORIZE COUNTIES AND MUNICIPALITIES TO CONTRIBUTE 7 TO THE DEPARTMENT OF ARCHIVES AND HISTORY FOR THE PURPOSE OF PROVIDING FUNDS FOR THE LANDMARK GRANT PROGRAM; TO PROVIDE THAT 8 9 THE DEPARTMENT OF ARCHIVES AND HISTORY SHALL ADMINISTER THE MISSISSIPPI LANDMARK GRANT PROGRAM; TO REVISE THE PURPOSES FOR 10 11 WHICH FUNDS IN THE HISTORIC PROPERTIES TRUST FUND MAY BE USED; AND FOR RELATED PURPOSES. 12 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 13 14 SECTION 1. Section 39-5-23, Mississippi Code of 1972, is amended as follows: 15 39-5-23. (1) The Mississippi Department of Archives and History is hereby authorized and empowered to solicit and accept

- donations, bequests, devises, gifts and grants of money from 18
- 19 individuals, organizations and federal, state and local
- 20 governmental bodies, to be deposited in the Historic Properties
- 21 Trust Fund which is hereby created in the State Treasury.
- Contributions to the Historic Properties Trust Fund may be 2.2
- 23 undesignated or earmarked for the purpose of acquiring,
- 24 preserving, restoring, supporting, operating and administering
- 25 Mississippi Landmark properties or for use on specific historical
- 26 projects that have been authorized by the Department of Archives
- 27 and History. The State Treasurer shall invest all monies in the
- 28 Historic Properties Trust Fund as other state funds are authorized
- 29 to be invested, and any interest earned shall be deposited into
- the fund. \* \* \* 30
- (2) The Mississippi Department of Archives and History is 31

32 hereby authorized and empowered to solicit and accept donations,
```

- 33 bequests, devises, gifts and grants of money and real and personal
- 34 property. The Board of Trustees of the Department of Archives and
- 35 History may, in its discretion, sell such real and personal
- 36 property by public or private sale and shall deposit proceeds
- 37 derived from such sale into the Historic Properties Trust Fund.
- 38 (3) (a) The Board of Trustees of the Mississippi Department
- 39 <u>of Archives and History is authorized to establish the Mississippi</u>
- 40 Landmark Grant Program within the Historic Properties Trust Fund
- 41 to help ensure the preservation of Mississippi Landmark
- 42 properties.
- 43 (b) The Board of Trustees of the Mississippi Department
- 44 of Archives and History may deposit funds appropriated by the
- 45 <u>Legislature into the account established for the Mississippi</u>
- 46 <u>Landmark Grant Program within the Historic Properties Trust Fund.</u>
- 47 All funds deposited in the account for the Mississippi Landmark
- 48 Grant Program shall be used exclusively for the purpose of
- 49 <u>acquiring</u>, <u>preserving</u>, <u>restoring</u>, <u>supporting</u>, <u>operating</u> and
- 50 <u>administering Mississippi Landmark properties or those properties</u>
- 51 <u>to be designated as Mississippi Landmarks.</u>
- 52 <u>(c) The Mississippi Landmark Grant Program will be</u>
- 53 <u>funded from the principal balance and interest earned on the</u>
- 54 principal balance of the account established for the program.
- 55 However, the principal balance of such account shall never be
- 56 <u>expended below seventy-five percent (75%) of the total sums of</u>
- 57 Legislature appropriated funds deposited into the account.
- 58 (d) The board of supervisors of every county and the
- 59 governing authorities of every municipality in the state may make
- 60 <u>contributions to the Mississippi Department of Archives and</u>
- 61 <u>History</u>, to be deposited into the account for the Mississippi
- 62 Landmark Grant Program. Such contributions may be undesignated or
- 63 <u>earmarked for use on specific Mississippi Landmark properties.</u>
- (e) The Board of Trustees of the Mississippi Department

- of Archives and History shall have all powers necessary to
- 66 implement and administer the Mississippi Landmark Grant Program,
- 67 and the board of trustees shall promulgate all rules and
- 68 regulations necessary for the implementation and administration of
- 69 the program.
- 70 SECTION 2. This act shall take effect and be in force from
- 71 and after July 1, 1999.
