COMMITTEE SUBSTITUTE FOR HOUSE BILL NO. 1309

AN ACT TO CREATE A NEW CODE SECTION TO BE CODIFIED AS SECTION 41-26-103, MISSISSIPPI CODE OF 1972, TO REQUIRE THE STATE 3 DEPARTMENT OF HEALTH TO DEVELOP ANNUALLY A LIST OF POTENTIALLY NON-VIABLE COMMUNITY PUBLIC WATER SYSTEMS AND TO REQUIRE THE 5 DEPARTMENT OF HEALTH TO OFFER THOSE SYSTEMS TECHNICAL ASSISTANCE AT NO COST TO THE SYSTEM; TO REQUIRE THE DEPARTMENT OF HEALTH TO NOTIFY THE PUBLIC UTILITIES STAFF IF THE SYSTEM REFUSES THE 6 7 ASSISTANCE OR FAILS TO RESPOND; TO AUTHORIZE THE PUBLIC UTILITY 8 STAFF TO CONDUCT A FINANCIAL OR MANAGERIAL REVIEW, OR BOTH, ON 9 SYSTEMS REFUSING ASSISTANCE OF FAILING TO RESPOND; TO AUTHORIZE 10 11 THE PUBLIC UTILITIES STAFF TO ASSESS AND COLLECT THE COSTS OF THE REVIEW OR REVIEWS FROM THE APPROPRIATE SYSTEM; AND FOR RELATED 12 13 PURPOSES. 14 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 15 SECTION 1. The following shall be codified as Section 41-26-103, Mississippi Code of 1972: 16 17 41-26-103. (1) The department shall develop annually a list 18 of community public water systems that the department, after consultation with the public utilities staff, considers to be 19 20 potentially nonviable or experiencing other problems that may make the system potentially nonviable. The list shall state the areas 21 of concern and shall be prioritized based upon viability 22 considerations. The department shall notify at a minimum those 23 systems shown in top ten (10) places on the list and shall offer 24 25 to provide each of those systems with technical assistance pertaining to the areas of concern for the system at no cost to 26 27 the system. If the notified community public water system refuses the offer of technical assistance at no cost to the system or 28 fails to respond within sixty (60) days of the written offer, the 29

department shall notify the public utilities staff in writing.

(2) Following receipt of notification from the department

- 32 that a community public water system has refused to accept
- 33 technical assistance or failed to respond, the public utilities
- 34 staff may conduct a financial or managerial review, or both, of
- 35 the system and shall submit a copy of any report to the
- 36 department. The public utilities staff may assess and collect the
- 37 cost of any financial or management review, or both, from the
- 38 community public water system on which the review or reviews are
- 39 conducted.
- 40 (3) This section shall be repealed on July 1, 2002.
- 41 SECTION 2. This act shall take effect and be in force from
- 42 and after July 1, 1999.
