HOUSE BILL NO. 1331

1 AN ACT MAKING A REAPPROPRIATION TO THE DEPARTMENT OF FINANCE  
2 AND ADMINISTRATION TO REAUTHORIZE THE EXPENDITURE OF STATE GENERAL  
3 FUNDS AND SPECIAL FUNDS PREVIOUSLY APPROPRIATED FOR CONSTRUCTION  
4 AND/OR REPAIR AND RENOVATION PROJECTS AT VARIOUS STATE AGENCIES  
5 AND INSTITUTIONS, FOR FISCAL YEAR 2000.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

7 SECTION 1. The following sum, or so much thereof as may be  
8 necessary, is hereby reappropriated out of any money in the State  
9 General Fund not otherwise appropriated, to the Department of  
10 Finance and Administration, acting through the Bureau of Building,  
11 Grounds and Real Property Management, for the purpose of  
12 reauthorizing the expenditure of State General Funds, as  
13 authorized in Senate Bill No. 3199, Regular Session of 1995,  
14 Senate Bill No. 2503, Regular Session of 1996, Senate Bill No.  
15 2427, Regular Session of 1997, and House Bill No. 1684, Regular  
16 Session of 1998, for the fiscal year beginning July 1, 1999, and  
17 ending June 30, 2000.....  
18 ..... \$ 1,411,045.00.

19 This reappropriation is made for the purpose of reauthorizing  
20 the expenditure of State General Funds for renovating and/or  
21 repairing existing state-owned facilities and for purchasing  
22 and/or replacing furniture and equipment for all institutions,  
23 agencies and departments of the State of Mississippi.

24 Notwithstanding the amount reappropriated under the  
25 provisions of this section, in no event shall the amount expended  
26 exceed the unexpended balance as of June 30, 1999, or change the  
27 purpose for which the funds were originally authorized.

28 SECTION 2. The following sum, or so much thereof as may be  
29 necessary, is hereby reappropriated out of any money in the State  
30 Treasury to the credit of Fund No. 3931, to the Department of  
31 Finance and Administration, acting through the Bureau of Building,  
32 Grounds and Real Property Management, for the purpose of  
33 reauthorizing the expenditure of funds previously appropriated for  
34 construction and/or repair and renovation projects at various  
35 state agencies and institutions, for the fiscal year beginning  
36 July 1, 1999, and ending June 30, 2000.....  
37 ..... \$ 43,483,542.00.

38 This reappropriation is made for the purpose of reauthorizing  
39 the expenditure of special funds for construction and/or repair  
40 and renovation projects at various state agencies and institutions  
41 that had been authorized by the Legislature in prior fiscal years.

42 Notwithstanding the amount reappropriated under the  
43 provisions of this section, in no event shall the amount expended  
44 exceed the unexpended balance as of June 30, 1999, or change the  
45 purpose for which the funds were originally authorized.

46 SECTION 3. The following sum, or so much thereof as may be  
47 necessary, is hereby reappropriated out of any money in the State  
48 Treasury to the credit of the Education Enhancement Fund No. 4900,  
49 to the Department of Finance and Administration, acting through  
50 the Bureau of Building, Grounds and Real Property Management, for  
51 the purpose of reauthorizing the expenditure of funds previously  
52 appropriated for construction and/or repair and renovation  
53 projects at various state agencies and institutions, for the  
54 fiscal year beginning July 1, 1999, and ending June 30, 2000  
55 ..... \$ 1,541,351.00.

56 This reappropriation is made for the purpose of reauthorizing  
57 the expenditure of special funds for construction and/or repair  
58 and renovation projects at various state agencies and institutions  
59 that had been authorized by the Legislature in prior fiscal years.

60 Notwithstanding the amount reappropriated under the

61 provisions of this section, in no event shall the amount expended  
62 exceed the unexpended balance as of June 30, 1999, or change the  
63 purpose for which the funds were originally authorized.

64 SECTION 4. The Bureau of Building, Grounds and Real Property  
65 Management of the Office of General Services is hereby expressly  
66 authorized and empowered to receive, budget and expend any state,  
67 local or other source funds designated for supplemental funding of  
68 construction and/or repair and renovation projects.

69 SECTION 5. The money herein appropriated shall be paid by  
70 the State Treasurer out of any money in the State Treasury to the  
71 credit of the proper fund or funds as set forth in this act, upon  
72 warrants issued by the State Fiscal Officer; and the State Fiscal  
73 Officer shall issue his warrants upon requisitions signed by the  
74 proper person, officer or officers, in the manner provided by law.

75 SECTION 6. This act shall take effect and be in force from  
76 and after July 1, 1999.
