## HOUSE BILL NO. 1448 (As Passed the House)

1 2 3 4 5	AN ACT TO AMEND SECTION 75-60-15, MISSISSIPPI CODE OF 1972, TO RESTORE THE FEE ASSESSED UNDER THE MISSISSIPPI PROPRIETARY SCHOOL AND COLLEGE REGISTRATION LAW WHICH IS BASED ON THE APPLICANT SCHOOL'S GROSS ANNUAL TUITION INCOME; AND FOR RELATED PURPOSES.
6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
7	SECTION 1. Section 75-60-15, Mississippi Code of 1972, is
8	amended as follows:
9	75-60-15. (1) The initial application fee shall be Five
10	Hundred Dollars (\$500.00), which shall accompany each application
11	for certificate of registration, and the renewal fee shall be Two
12	Hundred Fifty Dollars (\$250.00). There shall be an additional
13	initial fee based upon the applicant school's gross tuition income
14	collected during the first year after registration, according to
15	the following schedule:
16	GROSS ANNUAL TUITION INCOME FEE
17	<u>0 - \$1,249,999.00</u>
18	\$1,250,000.00 or above
19	The additional fee shall be paid within thirty (30) days
20	after the end of the year. There shall be an additional annual
21	renewal fee based upon the school's gross tuition income collected
22	during the previous license year, according to the same schedule,
23	which shall accompany the school's application for renewal. The
24	additional and renewal fees are each subject to a maximum fee of
25	Ten Thousand Dollars (\$10,000.00) and a minimum fee of Fifty
26	Dollars (\$50.00).
27	(2) If a renewal fee is not paid at least thirty (30) days

- 28 prior to the expiration of a school's certificate of registration,
- 29 in addition to the renewal fee, there shall be a delinquent fee of
- 30 one-tenth of one percent (1/10 of 1%) of such school's gross
- 31 tuition revenues collected during the previous registration year,
- 32 with a maximum fee of Two Thousand Five Hundred Dollars
- 33 (\$2,500.00) and a minimum fee of Twenty-five Dollars (\$25.00).
- 34 The reinstatement registration fee for a suspended school shall be
- 35 Five Hundred Dollars (\$500.00). No portion of any license fee
- 36 shall be subject to refund.
- 37 (3) A certificate of registration shall be issued or denied
- 38 within sixty (60) days after receipt of the application by the
- 39 commission.
- 40 (4) No new program of study shall be offered by any school
- 41 holding a certificate of registration until it is registered with
- 42 and approved by the commission in accordance with procedures which
- 43 shall be established by the commission. After such course is
- 44 registered in accordance with the approval procedures provided for
- 45 herein, it shall be included as a part of any renewal of a
- 46 certificate of registration. Each application for the original
- 47 registration of a new course shall be accompanied by a fee of One
- 48 Hundred Dollars (\$100.00).
- 49 (5) A certificate of registration shall be valid only for
- 50 the school and courses for which it is issued and shall not
- 51 include other schools or additional locations of a school unless
- 52 each such additional location: (a) offers only courses which are
- 53 identical to courses offered at the registered location: and (b)
- 54 is under the same ownership, management and control as that of the
- 55 registered location except as may be provided otherwise in this
- 56 section. Such additional locations meeting such requirements
- 57 shall be identified as "annexes" on a certificate application.
- 58 Gross tuition revenues for the registered location and all annexes
- 59 shall be combined for the purpose of determining fees payable
- 60 under this section.

- 61 (6) The fee submitted with the application is not returnable
- 62 to the applicant, even though a certificate of registration is not
- 63 issued.
- SECTION 2. This act shall take effect and be in force from
- 65 and after July 1, 1999.
