HOUSE BILL NO. 1560 (As Sent to Governor)

AN ACT TO AMEND CHAPTER 943, LOCAL AND PRIVATE LAWS OF 1993, 1 2 TO AUTHORIZE THE GOVERNING AUTHORITIES OF THE CITY OF MERIDIAN TO 3 GRANT A ONE-TIME AD HOC MONTHLY BENEFIT INCREASE AND TO INCREASE THE MINIMUM MONTHLY BENEFITS TO PERSONS RECEIVING ANY KIND OF 4 5 BENEFITS FROM THE MERIDIAN POLICE AND FIRE DISABILITY AND RELIEF 6 FUND OR THE MERIDIAN GENERAL MUNICIPAL EMPLOYEE RETIREMENT FUND; 7 TO PROVIDE THAT MINIMUM MONTHLY BENEFITS SHALL NOT BE PAID UNLESS 8 THE APPROPRIATE FUND IS ACTUARIALLY SOUND AND WILL REMAIN ACTUARIALLY SOUND IF THE MINIMUM MONTHLY BENEFITS ARE PAID; AND 9 10 FOR RELATED PURPOSES.

11 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 12 SECTION 1. Chapter 943, Local and Private Laws of 1993, is 13 amended as follows:

Section 1. (1) Subject to the provisions of subsection (2) 14 15 of this section, the governing authorities of the City of Meridian, Mississippi, are authorized, in their discretion, to 16 provide for the payment of minimum monthly benefits of not less 17 than Four Hundred Dollars (\$400.00) per month from monies 18 19 accumulated in the Meridian Police and Fire Disability and Relief 20 Fund to all persons now or hereafter entitled to receive benefits under any provision of Section 21-29-101 et seq., Mississippi Code 21 22 of 1972, by virtue of service as a member of, or through a member 23 of, the fire and/or police department of the City of Meridian. Persons who, on June 30, 1999, are receiving a retirement 24 25 allowance under Section 21-29-101 et seq. shall receive an 26 increase in monthly benefits equal to three and nine-tenths 27 percent (3.9%). If the resulting increased benefit amount is less 28 than Six Hundred Dollars (\$600.00) per month, such benefit amount 29 shall be increased to a minimum payment of Six Hundred Dollars

30 (\$600.00) per month. Any retiree, or beneficiary thereof, who

31 retires on or after July 1, 1999, shall receive a benefit in an 32 amount equal to no less than Six Hundred Dollars (\$600.00) per month. The governing authorities of the City of Meridian are 33 34 authorized to levy such millage as is necessary, in addition to 35 any other tax authorized by law, to make the minimum payment 36 provided herein and maintain the retirement fund on a sound 37 actuarial basis. The proceeds of any such additional millage 38 shall be excluded from the ten percent (10%) increase limitation under Section 27-39-321, Mississippi Code of 1972, for the first 39 year of such additional levy and shall be included within such 40 41 limitation in any year thereafter.

(2) Payment of the minimum monthly benefits authorized under 42 43 subsection (1) of this section shall not be established unless the Meridian Police and Fire Disability and Relief Fund is actuarially 44 sound, as shown by the most recent actuarial study required by 45 Section 21-29-119, Mississippi Code of 1972, and the fund will 46 remain actuarially sound if the minimum monthly benefits are made, 47 48 as shown by a certified statement from the actuarial firm that 49 prepared the most recent actuarial study.

50 After the governing authorities of the City of Meridian (3) have adopted a resolution specifying the amount of the minimum 51 monthly benefits authorized under subsection (1) of this section, 52 and the advisory board provided for in Section 21-29-105, 53 54 Mississippi Code of 1972, has adopted a resolution supporting the 55 payment of the specified amount of the minimum monthly benefits, and after the Board of Trustees of the Public Employees' 56 57 Retirement System has received these resolutions and the most recent actuarial study of the disability and relief fund and the 58 certified statement from the actuarial firm, pursuant to 59 60 subsection (2) of this section, that the fund will remain actuarially sound if the minimum monthly benefits are paid, then 61 62 the board of trustees shall pay those benefits to the persons authorized and entitled to receive the payments. 63

64 (4) Persons eligible to receive the minimum monthly benefits
65 authorized under this section shall receive such payments monthly
66 effective January 1, 1994. In the event of death of a person or a
67 beneficiary thereof receiving monthly benefits, any remaining

68 amounts shall be paid in a lump sum to the designated beneficiary. 69 Section 2. (1) Subject to the provisions of subsection (2) 70 of this section, the governing authorities of the City of Meridian, Mississippi, are authorized, in their discretion, to 71 72 provide for the payment of minimum monthly benefits of not less than Four Hundred Dollars (\$400.00) per month from monies 73 74 accumulated in the Meridian General Municipal Employee Retirement Fund to all persons now or hereafter entitled to receive benefits 75 76 under any provision of Section 21-29-1 et seq., Mississippi Code 77 of 1972, by virtue of service as an employee of the City of 78 Meridian. Persons who, on June 30, 1999, are receiving a 79 retirement allowance under Section 21-29-1 et seq. shall receive an increase in monthly benefits equal to three and nine-tenths 80 percent (3.9%). If the resulting increased benefit amount is less 81 than Six Hundred Dollars (\$600.00) per month, such benefit amount 82 83 shall be increased to a minimum payment of Six Hundred Dollars (\$600.00) per month. Any retiree, or beneficiary thereof, who 84 retires on or after July 1, 1999, shall receive a benefit in an 85 amount equal to no less than Six Hundred Dollars (\$600.00) per 86 87 month. The governing authorities of the City of Meridian are 88 authorized to levy such millage, in addition to any other tax authorized by law, as is necessary to make the minimum payment 89 90 provided herein and maintain the retirement fund on a sound actuarial basis. The proceeds of any such additional millage 91 shall be excluded from the ten percent (10%) increase limitation 92 93 under Section 27-39-321, Mississippi Code of 1972, for the first year of such additional levy and shall be included within such 94 95 limitation in any year thereafter.

96 (2) Payment of the minimum monthly benefits authorized under 97 subsection (1) of this section shall not be established unless the 98 Meridian General Municipal Employee Retirement Fund is actuarially 99 sound, as shown by the most recent actuarial study required by 100 Section 21-29-27, Mississippi Code of 1972, and the fund will

101 remain actuarially sound if the minimum monthly benefits are made, 102 as shown by a certified statement from the actuarial firm that 103 prepared the most recent actuarial study.

(3) After the governing authorities of the City of Meridian 104 105 have adopted a resolution specifying the amount of the minimum monthly benefits authorized under subsection (1) of this section, 106 107 and the advisory board provided for in Section 21-29-9, 108 Mississippi Code of 1972, has adopted a resolution supporting the 109 payment of the specified amount of the minimum monthly benefits, 110 and after the Board of Trustees of the Public Employees' Retirement System has received these resolutions and the most 111 112 recent actuarial study of the disability and relief fund and the certified statement from the actuarial firm, pursuant to 113 subsection (2) of this section, that the fund will remain 114 actuarially sound if the minimum monthly benefits are paid, then 115 116 the board of trustees shall pay those benefits to the persons 117 authorized and entitled to receive the payments.

(4) Persons eligible to receive the minimum monthly benefits authorized under this section shall receive such payments monthly effective January 1, 1994. In the event of death of a person or a beneficiary thereof receiving monthly benefits, any remaining amounts shall be paid in a lump sum to the designated beneficiary. SECTION 2. This act shall take effect and be in force from and after its passage.
