HOUSE BILL NO. 1588
(As Passed the House)

1 AN ACT MAKING AN APPROPRIATION FROM SPECIAL FUNDS IN THE
2 STATE TREASURY FOR THE PURPOSE OF DEFRAYING THE ADMINISTRATIVE
3 EXPENSES OF THE BOARD OF TRUSTEES OF THE PUBLIC EMPLOYEES'
4 RETIREMENT SYSTEM AND FOR THE MAINTENANCE AND OPERATION OF THE
5 RETIREMENT SYSTEM BUILDING FOR THE FISCAL YEAR 2000.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

7 SECTION 1. The following sum, or so much thereof as may be
8 necessary, is hereby appropriated out of any money in the State
9 Treasury to the credit of the Administrative Expense Account of
10 the Public Employees' Retirement System for the purpose of
11 defraying the administrative expenses of the Board of Trustees of
12 the Public Employees' Retirement System, or out of any money in
13 the State Treasury to the credit of the Retirement System Building
14 Account of the Public Employees' Retirement System for the purpose
15 of maintenance and general operation of the Retirement System
16 Building, for the fiscal year beginning July 1, 1999, and ending
17 June 30, 2000..... \$ 7,493,520.00.

18 SECTION 2. Of the funds appropriated under the provisions of
19 Section 1, not more than the amounts set forth below shall be
20 expended for the respective major objects or purposes of
21 expenditure:

38 From the funds provided in the budget category "Personal
39 Services: Salaries, Wages and Fringe Benefits," funds may be
40 expended for the following purposes, in compliance with the
41 policies established by the State Personnel Board and any
42 conditions placed on such expenditures:

43 (a) The components of the Variable Compensation Plan
44 shall be maintained within the constraints of the funds
45 appropriated herein.

46 (b) Funds are provided to adjust the Variable
47 Compensation Plan, including realignment, to ensure that all
48 full-time employees with at least six (6) months of continuous
49 current service, as of June 30, 1999, receive an increase of One
50 Thousand Five Hundred Dollars (\$1,500.00). Funds are provided to
51 adjust critical job classes up to an additional One Thousand
52 Dollars (\$1,000.00).

53 (c) If an employee is currently at or above the end
54 salary for his or her job classification, then the increase shall
55 be built into the employee's base salary. To be eligible for any
56 increase authorized in this section, employees may not have a
57 current performance rating below "meets expectations" as of the
58 effective date of the increase. Employees who subsequently
59 receive a performance rating of "meets expectations" or above
60 during Fiscal Year 2000 shall receive the salary increase

61 effective the date of the rating.

62 It is the agency's responsibility to make certain that funds
63 required to be appropriated for "Personal Services" for Fiscal
64 Year 2001 do not exceed Fiscal Year 2000 funds appropriated for
65 that purpose unless programs or positions are added to the
66 agency's budget by the Mississippi Legislature.

67 Any transfers or escalations shall be made in accordance with
68 the terms, conditions and procedures established by law.

69 No general funds authorized to be expended herein shall be
70 used to replace federal funds and/or other special funds which are
71 being used for salaries authorized under the provisions of this
72 act and which are withdrawn and no longer available.

73 SECTION 3. Of the funds appropriated in Section 1 and
74 allocated in Section 2 in the category "Personal Services:
75 Salaries, Wages and Fringe Benefits," not more than Fifty Thousand
76 Dollars (\$50,000.00) shall be used to pay overtime compensation
77 for work on data processing records after regular office hours.

78 SECTION 4. The following sum, or so much thereof as may be
79 necessary is hereby appropriated out of any money in the State
80 Treasury to the credit of the Administrative Expense Account of
81 the Public Employees' Retirement System for the purpose of
82 defraying the expenses of implementing the information technology
83 plan know as "Genesis", for the fiscal year beginning
84 July 1, 1999, and ending June 30, 2000..... \$ 600,000.00.

85 SECTION 5. Funds are provided in this act for the
86 reallocation of an Optimal Imaging Operator to an Administrative
87 Assistant III not to exceed One Thousand One Hundred Thirty-nine
88 Dollars (\$1,139.00).

89 SECTION 6. Funds are provided in this act for the
90 reallocation of an Investment Accountant to an Investment Manager
91 not to exceed Two Thousand Three Hundred Twenty-nine Dollars
92 (\$2,329.00).

93 SECTION 7. The money herein appropriated shall be paid by

94 the State Treasurer out of any money in the State Treasury to the
95 credit of the proper fund or funds as set forth in this act, upon
96 warrants issued by the State Fiscal Officer; and the State Fiscal
97 Officer shall issue his warrants upon requisitions signed by the
98 proper person, officer or officers, in the manner provided by law.

99 SECTION 8. This act shall take effect and be in force from
100 and after July 1, 1999.
