No. 1592 99\HR05\A828 PAGE 1 full-time employees with at least six (6) months of continuous current service, as of June 30, 1999, receive an increase of One Thousand Five Hundred Dollars (\$1,500.00). Funds are provided to adjust critical job classes up to an additional One Thousand Dollars (\$1,000.00).

If an employee is currently at or above the end 32 (C) salary for his or her job classification, then the increase shall 33 34 be built into the employee's base salary. To be eligible for any increase authorized in this section, employees may not have a 35 current performance rating below "meets expectations" as of the 36 effective date of the increase. Employees who subsequently 37 receive a performance rating of "meets expectations" or above 38 39 during Fiscal Year 2000 shall receive the salary increase effective the date of the rating. 40

It is the agency's responsibility to make certain that funds required to be appropriated for "Personal Services" for Fiscal Year 2001 do not exceed Fiscal Year 2000 funds appropriated for that purpose unless programs or positions are added to the agency's budget by the Mississippi Legislature.

Any transfers or escalations shall be made in accordance with the terms, conditions and procedures established by law.

No general funds authorized to be expended herein shall be used to replace federal funds and/or other special funds which are being used for salaries authorized under the provisions of this act and which are withdrawn and no longer available.

52 Of the above funds, none may be expended by this act to 53 provide for any regulatory authority over livestock auctioneers 54 conducting sales for an individual of his own property.

55 SECTION 3. The money herein appropriated shall be paid by 56 the State Treasurer out of any money in the State Treasury to the credit of the proper fund or funds as set forth in this act, upon 57 warrants issued by the State Fiscal Officer; and the State Fiscal 58 Officer shall issue his warrants upon requisitions signed by the 59 proper person, officer or officers, in the manner provided by law. 60 61 SECTION 4. This act shall take effect and be in force from 62 and after July 1, 1999.
