AN ACT APPROVING THE EXPENDITURE OF SPECIAL FUNDS FOR THE PURPOSE OF DEFRAYING THE EXPENSES OF THE PEARL RIVER VALLEY WATER 1 2 3 SUPPLY DISTRICT FOR THE FISCAL YEAR 2000. 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 5 SECTION 1. The following sum, or so much thereof as may be 6 necessary, is hereby authorized and approved for expenditure out of any funds which are received by or otherwise become available to the Pearl River Valley Water Supply District, for the purpose 8 9 of defraying the expenses of the district for the fiscal year beginning July 1, 1999, and ending June 30, 2000..... 10 However, funds derived from the special tax levy authorized 11 12 under the provisions of Section 51-9-139, Mississippi Code of 13 1972, shall be expended only for principal of and interest on bonds and shoreline development. 14 SECTION 2. - Any transfers or escalations shall be made in accordance with
- 65 the terms, conditions and procedures established by law.
- No general funds authorized to be expended herein shall be
- 67 used to replace federal funds and/or other special funds which are
- 68 being used for salaries authorized under the provisions of this
- 69 act and which are withdrawn and no longer available.
- 70 SECTION 3. Of the funds authorized and approved for
- 71 expenditure herein, it is the intention of the Legislature that
- 72 not less than twenty-five percent (25%) of all revenues obtained
- 73 from the sale of timber on the Pearl River Valley Supply District
- 74 property shall be used for the promotion and enhancement of
- 75 wildlife on the Pearl River Valley Supply District property. The
- 76 promotion and enhancement of wildlife and the expenditure of these
- 77 funds shall be under the supervision of and at the discretion of
- 78 the Department of Wildlife, Fisheries and Parks.
- 79 SECTION 4. The funds herein approved for expenditure, except
- 80 and less an amount approved by the State Fiscal Officer which
- 81 shall be sufficient to cover disbursements for current operations,
- 82 shall be deposited at interest with any official depository of the
- 83 state at a rate of interest numerically not less than one percent
- 84 (1%) below the bank discount rate on United States Treasury bills
- 85 of comparable maturity as determined by the State Treasurer.
- 86 SECTION 5. The money herein approved for expenditure shall
- 87 be disbursed upon bank checks signed by the proper person, officer
- 88 or officers, in the manner provided by law or in accordance with
- 89 the provisions of a valid trust indenture.
- 90 SECTION 6. This act shall take effect and be in force from
- 91 and after July 1, 1999.
