The money herein appropriated shall be paid by 138 139 the State Treasurer out of any money in the State Treasury to the credit of the proper fund or funds as set forth in this act, upon 140 warrants issued by the State Fiscal Officer; and the State Fiscal 141 Officer shall issue his warrants upon requisitions signed by the 142 proper person, officer or officers, in the manner provided by law. 143 SECTION 10. This act shall take effect and be in force from 144
