HOUSE BILL NO. 1703 (As Passed the House)

- 7 SECTION 1. Chapter 970, Local and Private Laws of 1997, is

- Section 1. (1) For the purpose of enhancing commerce, 9
- industry and sport fishing in Jackson County, Mississippi, the 10
- Board of Supervisors of Jackson County, in its discretion, is 11
- authorized to designate certain property located in Section 14, 12

- Section 2. The Board of Supervisors of Jackson County, 23
- Mississippi, acting by and through the Jackson County Port 2.4
- Authority, is authorized and empowered, in its discretion, to 25
- extend the water and sewer lines of the Sunplex Light Industrial 26
- 27 Park water and sewer system to areas outside the park to make

- 28 water and sewer available to commercial service, general business
- 29 and residential development in the Mississippi Highway 57 area
- 30 north of U.S. Highway 90 and extending northerly through the
- 31 <u>intersection</u> of <u>Robinson Still Road</u> and Mississippi Highway 57.
- 32 Section 3. The Board of Supervisors of Jackson County,
- 33 acting by and through the Jackson County Port Authority, is
- 34 further authorized, in its discretion, to apply for grants and/or
- 35 acquire by donation, purchase, lease or otherwise, such funds,
- 36 properties, rights-of-way or easements, and/or to enter into such
