1 2 3 4 5	A CONCURRENT RESOLUTION PROPOSING AMENDMENTS TO SECTION 34 AND SECTION 35, MISSISSIPPI CONSTITUTION OF 1890, TO LIMIT THE TERMS OF OFFICE FOR MEMBERS OF THE HOUSE OF REPRESENTATIVES AND MEMBERS OF THE SENATE TO THREE SUCCESSIVE TERMS; AND FOR RELATED PURPOSES.
6	BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF
7	MISSISSIPPI, That the following amendments to the Mississippi
8	Constitution of 1890 are proposed to the qualified electors of the
9	state:
10	I.
11	Amend Section 34, Mississippi Constitution of 1890, to read
12	as follows:
13	"Section 34. The House of Representatives shall consist of
14	members chosen every four (4) years by the qualified electors of
15	the several counties and representative districts. <u>Any person</u>
16	elected to the House of Representatives shall be eligible to
17	succeed himself in office, but no person who has been elected to
18	the House of Representatives for three (3) successive terms after
19	the ratification of this amendment shall be eligible to hold that
20	office until four (4) years have intervened."
21	II.
22	Amend Section 35, Mississippi Constitution of 1890, to read
23	as follows:
24	"Section 35. The Senate shall consist of members chosen
25	every four (4) years by the qualified electors of the several
26	districts. Any person elected to the Senate shall be eligible to
27	succeed himself in office, but no person who has been elected to

29 of this amendment shall be eligible to hold that office until four

30 (4) years have intervened."

31 BE IT FURTHER RESOLVED, That these proposed amendments shall 32 be submitted by the Secretary of State to the qualified electors 33 at an election to be held on the first Tuesday after the first 34 Monday of November 1999, as provided by Section 273 of the 35 Constitution and by general law, with the amendments in this 36 resolution being voted on as one (1) amendment since the proposed 37 amendments pertain to one (1) subject.

38 BE IT FURTHER RESOLVED, That the explanation of this proposed 39 amendment for the ballot shall read as follows: "This proposed 40 constitutional amendment limits the terms of office for members of 41 the House of Representatives and members of the Senate to three 42 successive terms."

BE IT FURTHER RESOLVED, That the Attorney General of the State of Mississippi shall submit this resolution, immediately upon adoption by the Legislature, to the Attorney General of the United States or to the United States District Court for the District of Columbia, in accordance with the provisions of the Voting Rights Act of 1965, as amended and extended.
