HOUSE CONCURRENT RESOLUTION NO. 8

A CONCURRENT RESOLUTION RESCINDING AND WITHDRAWING HOUSE 1 2 CONCURRENT RESOLUTION NO. 14, 1973 REGULAR SESSION, HOUSE CONCURRENT RESOLUTION NO. 55, 1973 REGULAR SESSION, HOUSE 3 CONCURRENT RESOLUTION NO. 51, 1975 REGULAR SESSION, HOUSE CONCURRENT RESOLUTION NO. 3, 1979 REGULAR SESSION, AND ALL OTHER 4 5 RESOLUTIONS ADOPTED BY THE MISSISSIPPI LEGISLATURE THAT HAVE 6 7 MEMORIALIZED CONGRESS TO CALL A CONSTITUTIONAL CONVENTION; AND URGING OTHER STATE LEGISLATIVE BODIES TO DO THE SAME WITH REGARD 8 9 TO SIMILAR RESOLUTIONS, PETITIONS, APPLICATIONS OR OTHER PAPERS 10 ADOPTED BY SUCH BODIES.

11 WHEREAS, the Legislature of the State of Mississippi, acting 12 with the best of intentions, at various times, has previously made 13 applications to the Congress of the United States of America for 14 one or more constitutional conventions for general purposes or for 15 the limited purposes of considering amendments to the Constitution 16 of the United States of America on various subjects and for

17 various purposes; and

WHEREAS, former justices of the United States Supreme Court 18 and other leading constitutional scholars are in general agreement 19 20 that a constitutional convention, notwithstanding whatever limitations have been specified in the applications of the several 21 22 states for a convention, would have within the scope of its 23 authority the complete redrafting of the Constitution of the United States of America, thereby creating the imminent peril to 24 25 our well-established rights and to the constitutional principles 26 under which we are presently governed; and

27 WHEREAS, the Constitution of the United States of America has 28 been amended many times in the history of the nation and may yet 29 be amended many more times, and has been interpreted for two 30 hundred years and has been found to be a basically sound document

31 which protects the rights and liberties of the people, without 32 ever having the need to resort to a convention; and

33 WHEREAS, there is no need for, rather, there is a great 34 danger in, a new Constitution, the adoption of which would only 35 create legal chaos in America and only begin the process of 36 another two centuries of litigation over its meaning and 37 interpretation; and

38 WHEREAS, such changes or amendments as may be needed in the 39 present Constitution may be proposed and enacted as provided 40 therein and as previously used throughout the history of this 41 nation, without resort to a constitutional convention:

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF 42 43 REPRESENTATIVES OF THE STATE OF MISSISSIPPI, THE SENATE CONCURRING THEREIN, That any and all extant resolutions to the Congress of 44 the United States of America for a constitutional convention or 45 conventions, heretofore made by the Legislature of the State of 46 Mississippi under Article V of the Constitution of the United 47 States of America for any purpose, whether general or limited, are 48 49 hereby repealed, rescinded, cancelled, superseded and rendered 50 null and void to the same effect as if such resolutions had never been made. 51

BE IT FURTHER RESOLVED, That this resolution supersedes all 52 previous resolutions memorializing the Congress of the United 53 States to call a convention to propose an amendment to the 54 55 Constitution of the United States, including House Concurrent Resolution No. 14, 1973 Regular Session, House Concurrent 56 57 Resolution No. 55, 1973 Regular Session, House Concurrent Resolution No. 51, 1975 Regular Session, and House Concurrent 58 59 Resolution No. 3, 1979 Regular Session, and that such previous 60 resolutions are rescinded and withdrawn.

BE IT FURTHER RESOLVED, That copies of this resolution be furnished to the President of the United States Senate, to the Speaker of the United States House of Representatives, to presiding officers of both houses of the legislature of each of the other states of the Union, to the members of the Congress of the United States representing the State of Mississippi, and to the Administrator of General Services of the government of the
