- MISSISSIPPI TRANSPORTATION COMMISSIONERS TO DESIGNATE THE GREAT 3
- RIVER BRIDGE AS THE CHARLES W. DEAN BRIDGE.
- 5 WHEREAS, Charles William Dean, a professional engineer from
- Cleveland, Mississippi, conceived the first serious idea in 1984 6
- 7 for a bridge across the Mississippi River at Rosedale; and
- WHEREAS, as Co-Chairman of the Arkansas-Mississippi Great 8
- River Bridge Authority, Charles Dean further developed his idea of 9
- 10 the Great River Bridge working closely with leaders from Arkansas
- and Mississippi; and 11
- 12 WHEREAS, when the Interstate 69 project began in the
- 13 mid-nineties, Charles Dean realized that the Great River Bridge
- would be the ideal Mississippi River crossing for Interstate 69; 14
- 15 and
- WHEREAS, Charles Dean became involved in the promotion of the 16
- 17 construction of Interstate 69 and he serves on the Board of
- Directors of the I-69 Coalition; and 18
- 19 WHEREAS, during his career as a professional engineer,
- 20 Charles Dean has specialized in river ports, drainage, municipal
- public works, airports, highways, railroads, industrial parks and 21
- 22 long-range planning; and
- WHEREAS, because of his dedication to his profession, his 23
- 24 community, his state and his country, the Legislature declares
- 25 that it would be most appropriate to name the Great River Bridge
- 26 the Charles W. Dean Bridge:
- NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF 2.7

- 28 REPRESENTATIVES OF THE STATE OF MISSISSIPPI, THE SENATE CONCURRING
- 29 THEREIN, That we do hereby memorialize the United States Congress,
- 30 the United States Department of Transportation and the Mississippi
- 31 Transportation Commissioners to designate the Great River Bridge
- 32 on Interstate 69 as the Charles W. Dean Bridge and that
- 33 appropriate memorials at appropriate locations be erected at each
- 34 end of such bridge.
- 35 BE IT FURTHER RESOLVED, That copies of this resolution be
- 36 furnished to the United States Congress, the United States
- 37 Department of Transportation, the Mississippi Transportation
- 38 Commissioners, the I-69 Coalition, the Arkansas-Mississippi Great
