- 21 Boys and Girls Ranches Builders Club and a former member of the

- 24 awards including Who's Who in American Law Enforcement, the Civil
- 25 Servant Award, the Wayne County Law Enforcement Officer of the
- 26 Year Award, the Distinguished Service Award and the County

- 28 WHEREAS, Sheriff Farrior has been supported in all his
- 29 endeavors by his lovely wife, Connie, their six children and
- 30 eleven grandchildren; and
