## HOUSE CONCURRENT RESOLUTION NO. 90

1 A CONCURRENT RESOLUTION COMMENDING THE LIFE AND WORKS OF 2 CHARLES WILLIAM DEAN AND EXPRESSING THE DEEPEST SYMPATHY OF THE 3 LEGISLATURE UPON HIS PASSING.

WHEREAS, Charles William Dean, a visionary civil engineer and lifelong advocate of Bolivar County, departed this life at the age of 70 on November 11, 1998, causing great loss to his many friends and his family; and

8 WHEREAS, Charles Dean, a graduate of Shaw High School and the 9 University of Mississippi, was involved in the community since his 10 early days at Ole Miss when he served as president of the student 11 body in 1948-1949; and

12 WHEREAS, Charles Dean was owner of Consulting Civil

13 Engineering in Cleveland where he specialized in river ports,

14 drainage, municipal public works, airports, highways, railroads,

15 industrial parks and long-range planning; and

16 WHEREAS, his expertise was greatly sought after in the area 17 of transportation and economic development and he traveled to 18 numerous foreign countries sharing that expertise, including 19 Japan, Korea, Hong Kong, England, the Netherlands, Belgium, 20 Germany, Mexico and the continent of South America; and

21 WHEREAS, in 1983 Charles Dean was invited to the Peoples 22 Republic of China where he shared his engineering expertise with 23 recommendations to develop China's river systems for

24 transportation and flood control; and

25 WHEREAS, Charles Dean was a member of the National Society of
 26 Professional Engineers; Mississippi Society of Professional

34 WHEREAS, at Ole Miss, Charles Dean was Past President of ODK, 35 the Hall of Fame, Kappa Sigma, the Varsity Football Team and his 36 graduating class; and

37 WHEREAS, Charles Dean received numerous awards during his 38 lifetime, including the Kossman Award from the Cleveland-Bolivar 39 County Chamber of Commerce and an award from the State of 40 Mississippi in economic development; and

WHEREAS, Charles Dean also served his community as a Boy
Scout leader and as a member of First United Methodist Church in
Cleveland, where he was on the board of trustees; and

WHEREAS, Charles Dean's vision of creating the
Arkansas-Mississippi Great River Bridge, nicknamed "Dean's Dream,"
will serve as a permanent monument to the unselfish service of
Charles Dean to his community upon its completion; and

48 WHEREAS, Charles Dean is survived by his wife of 48 years, 49 Martha Cile Dean; two daughters, Debbie Cole and Tommicile Rogers; 50 a son, Charles William Dean, Jr.; and 13 grandchildren; and

51 WHEREAS, it is the policy of the Legislature to pay tribute 52 to exemplary Mississippians such as Charles William Dean, who 53 devote their lives to the betterment of all citizens of the state:

54 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF 55 REPRESENTATIVES OF THE STATE OF MISSISSIPPI, THE SENATE CONCURRING 56 THEREIN, That we do hereby commend the life and works of Charles 57 William Dean and express our deepest sympathy to his family during 58 their time of loss.
