- 4 W. DEAN BRIDGE.
- 5 WHEREAS, Charles William Dean, a professional engineer from
- 6 Cleveland, Mississippi, conceived the first serious idea in 1984
- 7 for a bridge across the Mississippi River at Rosedale; and
- 8 WHEREAS, as Co-Chairman of the Arkansas-Mississippi Great
- 9 River Bridge Authority, Charles Dean further developed his idea of
- 10 the Great River Bridge working closely with leaders from Arkansas
- 11 and Mississippi; and
- 12 WHEREAS, when the Interstate 69 project began in the
- 13 mid-nineties, Charles Dean realized that the Great River Bridge
- 14 would be the ideal Mississippi River crossing for Interstate 69;
- 15 and
- 16 WHEREAS, Charles Dean became involved in the promotion of the
- 17 construction of Interstate 69 and he served on the Board of
- 18 Directors of the I-69 Coalition; and
- 19 WHEREAS, during his lifetime in his career as a professional
- 20 engineer, Charles Dean specialized in river ports, drainage,
- 21 municipal public works, airports, highways, railroads, industrial
- 22 parks and long-range planning; and
- 23 WHEREAS, because of his dedication to his profession, his
- 24 community, his state and his country, the Legislature declares
- 25 that it would be a fitting tribute to the life and works of an
- 26 exemplary Mississippian and most appropriate to name the Great
- 27 River Bridge the Charles W. Dean Bridge:

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF 28 REPRESENTATIVES OF THE STATE OF MISSISSIPPI, THE SENATE CONCURRING 29 30 THEREIN, That we do hereby memorialize the Mississippi Department of Transportation and the Mississippi Transportation Commissioners 31 32 to designate the Great River Bridge on Interstate 69 as the Charles W. Dean Bridge and that appropriate memorials at 33 34 appropriate locations be erected at each end of such bridge. BE IT FURTHER RESOLVED, That copies of this resolution be 35 36 furnished to the Mississippi Department of Transportation, the 37 Mississippi Transportation Commissioners, the I-69 Coalition, the Arkansas-Mississippi Great River Bridge Authority, the family of 38
