1 2	A CONCURRENT RESOLUTION COMMENDING DR. DON Q. MITCHELL FOR HIS OUTSTANDING ACCOMPLISHMENTS IN THE FIELD OF MEDICINE.
3	WHEREAS, Dr. Don Q. Mitchell, an allergy and immunology
4	specialist at the University of Mississippi School of Medicine,
5	has made outstanding contributions to the field of medicine

7	WHEREAS, Dr. Mitchell, a resident of Jackson, Mississippi,
8	was born on August 11, 1942, in Cleveland, Mississippi, and
9	graduated from Cleveland High School in 1960; and
10	WHEREAS, after graduating from high school, Dr. Mitchell
11	furthered his education at Millsaps College, where he earned a
12	bachelor of science degree in biology, and he earned his doctor of
13	medicine degree from the University of Mississippi School of
14	Medicine in 1967; and
15	WHEREAS, throughout his career, Dr. Mitchell's hospital
16	appointments include Chief of Medicine, Medical Executive
17	Committee, Chief of Allergy, Medical Education Committee,
18	Respiratory Therapy Committee, Utilization Review Committee,
19	Patient Education Committee and the Institutional Review Board,
20	which were all at the Mississippi Baptist Medical Center in

- 28 WHEREAS, Dr. Mitchell has served in various leadership
- 29 positions of several professional organizations such as a delegate

- 31 Mississippi State Medical Association, former president of the
