4 WHEREAS, Robert George Clark, Speaker Pro Tempore of	f the
5 Mississippi House of Representatives, has dedicated over	thirty
6 years of service to the people in the State of Mississipp	pi; and
WHEREAS, Speaker Clark, a native of Holmes County,	
8 Mississippi, earned an undergraduate degree from Jackson	State
9 University and a master's degree in administration and ed	ducational
10 services from Michigan State University; and	
11 WHEREAS, Speaker Clark also studied at Mississippi V	Valley
12 State University, Florida A & M University and Western M:	ichigan
13 University and, in 1979, he was a teaching fellow of the	John F.
14 Kennedy School of Government at Harvard University; and	
WHEREAS, representing District 47 and serving his es	ighth
16 consecutive term in the House of Representatives, Speaker	r Clark
17 initially sought election in hopes of providing adequate	education
18 for students in the rural hamlets of Mississippi; and	
19 WHEREAS, in January 1992, Representative Clark was e	elected by
20 his fellow legislators as the Speaker Pro Tempore of the	
21 Mississippi House of Representatives and was reelected to	o this
22 position at the beginning of the 1996 session; and	
WHEREAS, in 1977, Speaker Clark became the first Bla	ack
24 committee chairman in the Mississippi House of Representa	atives as
25 he was named Chairman of the Education Committee, a posit	tion he

held for ten pivotal years of change and reform in Mississippi's

- 28 WHEREAS, as Chairman of the Education Committee, Speaker
- 29 Clark led the House to pass the highly acclaimed 1982 Education
- 30 Reform Act, the 1984 Vocational Education Reform Act and the
- 31 Education Enhancement Act which provided Mississippi's schools
- 32 with the necessary funds to repair schools in numerous school
- 33 districts across the state; and
- 34 WHEREAS, during his legislative career, Speaker Clark has
- 35 served as Chairman of the House Ethics Committee and Vice Chairman
- 36 of the Apportionment and Elections Committee; and
- 37 WHEREAS, as Speaker Pro Tempore, he serves as Chairman of the
- 38 House Management Committee, which oversees internal business
- 39 affairs and personnel of the Mississippi House of Representatives,
- 40 and he is the senior ranking member of Mississippi's Legislative
- 41 Black Caucus; and
- WHEREAS, Speaker Clark was one of the original members of the
- 43 Board of Directors for Central Mississippi, Inc., an antipoverty
- 44 program covering several counties in Central Mississippi which,
- 45 among many other components, has a head start program that has
- 46 been instrumental in giving vast numbers of rural children a jump
- 47 start in preparedness for entering the mainstream public schools;
- 48 and
- WHEREAS, Speaker Clark also helped organize the Milton Olive
- 50 III Memorial Corp. of Holmes County, an antipoverty program
- 51 designed to provide essential medical care to individuals who were
- 52 in the greatest need; and
- 53 WHEREAS, Speaker Clark served as Director of Project Second
- 54 Start at Saints Junior College, an organization that focused on
- 55 giving adults an opportunity to develop skills in various
- 56 vocations that were necessary to increase their standard of living
- 57 and leading them to better employment; and
- WHEREAS, another community enrichment program Speaker Clark
- 59 organized was the Fine Housing Enterprise program which was
- 60 developed for the community to receive various forms of assistance
- 61 allowing numerous poor families in the county to afford decent
- 62 housing; and
- 63 WHEREAS, Speaker Clark has received numerous awards and

- 64 honors during his career, including the Alumnus of the Year Award
- 65 from Jackson State University, the Award of Distinction and
- 66 Outstanding Leadership Award from the University of Mississippi
- 67 and the Outstanding Achievement Award for Education in
- 68 Mississippi; and
- 69 WHEREAS, currently, Speaker Clark is working to bring a
- 70 correctional facility to Holmes County and with little or no
- 71 expense to the county, providing jobs to the residents and
- 72 enabling young criminals to pay their dues to society while being
- 73 detained close to home; and
- 74 WHEREAS, Speaker Clark has been lovingly supported in his
- 75 endeavors by his lovely wife, the former Jo Ann Ross, and their
- 76 children, LaLeche, Robert George III and Bryant Wandrick; and
- 77 WHEREAS, it is the policy of this Legislature to recognize
- 78 and pay special tribute to such an outstanding Mississippian as
- 79 Speaker Clark, a great pride to our state, for his immeasurable
- 80 contributions on behalf of the people of the State of Mississippi
- 81 during his long and distinguished career in public service:
