HOUSE CONCURRENT RESOLUTION NO. 108 (As Adopted by House and Senate)

A CONCURRENT RESOLUTION COMMENDING DR. JOHN LAMBERT ON BEING 1 2 NAMED MISSISSIPPI'S OUTSTANDING TREE FARMER OF THE YEAR. 3 WHEREAS, Dr. John Lambert of Covington County, Mississippi, 4 owner of the Lambert tree farm in Sumrall, has been named 5 Mississippi's Outstanding Tree Farmer of the Year; and WHEREAS, Dr. Lambert's interest in forestry began in 1955 6 7 when he took a course in forest management at Mississippi State University which taught him the importance of a well-thought-out 8 9 management plan; and WHEREAS, Dr. Lambert's family began purchasing the current 10 property for the tree farm in the 1920's, and between 1958 and 11 12 1983, Dr. Lambert added several tracts adjoining the original 13 property; and 14 WHEREAS, Lambert's tree farm is made up of 750 acres of highly productive forestland in Covington County, 400 of which are 15 16 old cotton fields planted in loblolly pine, and 350 of which are managed natural stands; and 17 WHEREAS, the land is composed of most stand types that are 18 19 present in South Mississippi, including the mature longleaf pine, the loblolly pine, the shortleaf pine and the mixed hardwood 20 21 stream bottoms; and WHEREAS, Dr. Lambert, a retired veterinarian, is actively 2.2 23 involved on a daily basis in the farm's planning and operation and 24 has kept a diary of all work done on the farm since it was 25 certified as a tree farm and placed under a written management plan in 1958; and 26

No. 108 99\HR03\R1941 PAGE 1 27 WHEREAS, Dr. Lambert's primary goals for the tree farm are to 28 maximize economic return on investment, sustain forest production, 29 replicate native longleaf pine ecosystem, restore wildlife and 30 wildflower habitat and protect the soil and water quality; and 31 WHEREAS, in addition to those goals, Dr. Lambert adds the 32 desire for a strict accounting of all activity on the farm and 33 minimum damage to the soil, water and standing timber; and

34 WHEREAS, over the years, numerous timber sales, which have 35 done little damage to residual stands, have yielded forest 36 products including poles, sawtimber and chip-n-saw; and

37 WHEREAS, Dr. Lambert is currently working with the Nature 38 Conservancy in replicating a longleaf pine ecosystem on the 39 property; and

40 WHEREAS, Dr. Lambert believes that maximum return from the 41 tree farm can happen alongside careful stewardship of the 42 environment; and

43 WHEREAS, it is the policy of the Legislature to recognize and 44 pay special tribute to outstanding Mississippians such as Dr. John 45 Lambert, whose family has strived for good forest and wildlife 46 management and benign treatment of the land:

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF
REPRESENTATIVES OF THE STATE OF MISSISSIPPI, THE SENATE CONCURRING
THEREIN, That we do hereby commend and congratulate Dr. John
Lambert on being named Mississippi's Outstanding Tree Farmer of
the Year and extend our heartiest wishes to him for success in all
his future endeavors.
