HOUSE CONCURRENT RESOLUTION NO. 136

1 A CONCURRENT RESOLUTION SUSPENDING THE DEADLINES FOR THE
2 PURPOSE OF THE FURTHER CONSIDERATION AND PASSAGE OF SENATE BILL
3 2407, REGULAR SESSION OF 1999, ENTITLED "AN ACT TO CREATE THE
4 "MISSISSIPPI AGRICULTURAL PROMOTIONS PROGRAM ACT" FOR THE PURPOSE
5 OF EXPANDING THE MARKET FOR MISSISSIPPI'S AGRICULTURAL PRODUCTS;
6 TO AUTHORIZE THE DEPARTMENT OF AGRICULTURE AND COMMERCE TO
7 ESTABLISH AND COORDINATE THE MISSISSIPPI AGRICULTURAL PROMOTIONS
8 PROGRAM; TO CREATE A SPECIAL FUND IN THE STATE TREASURY TO BE
9 DESIGNATED AS THE "MISSISSIPPI AGRICULTURAL PROMOTIONS FUND"; AND
10 FOR RELATED PURPOSES."

11 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE
12 OF MISSISSIPPI, THE SENATE CONCURRING THEREIN, That the Joint
13 Rules of the House and the Senate, including all the deadlines and
14 other provisions imposed by Joint Rule No. 40, are suspended for
15 the purpose of permitting the further consideration and passage of
16 Senate Bill 2407, Regular Session of 1999, entitled "AN ACT TO
17 CREATE THE "MISSISSIPPI AGRICULTURAL PROMOTIONS PROGRAM ACT" FOR
18 THE PURPOSE OF EXPANDING THE MARKET FOR MISSISSIPPI'S AGRICULTURAL
19 PRODUCTS; TO AUTHORIZE THE DEPARTMENT OF AGRICULTURE AND COMMERCE
20 TO ESTABLISH AND COORDINATE THE MISSISSIPPI AGRICULTURAL
21 PROMOTIONS PROGRAM; TO CREATE A SPECIAL FUND IN THE STATE TREASURY
22 TO BE DESIGNATED AS THE "MISSISSIPPI AGRICULTURAL PROMOTIONS
