HOUSE CONCURRENT RESOLUTION NO. 165 (As Adopted by House and Senate)

1 A CONCURRENT RESOLUTION COMMENDING THE MEMBERS OF THE 2 MISSISSIPPI HOUSE OF REPRESENTATIVES WHO BEGAN THEIR TERMS IN 1980 3 FOR THEIR OUTSTANDING SERVICE.

4 WHEREAS, of the 52 representatives who began their term in office in 1980, which is one of the largest freshman classes of 5 legislators, 12 are currently serving the 1996-2000 term; and 6 7 WHEREAS, the Class of 1980, includes Tyrone Ellis, Timothy Alan (Tim) Ford, David Leo (David) Green, Clayton P. (Clayton) 8 9 Henderson, Bennett Malone, William J. (Billy) McCoy, Thomas Upton (Tommy) Reynolds, II, Johnny William (Johnny) Stringer, Robert 10 Earl (Robert) Vince, Joseph Lawrence (Joe) Warren, III, Percy 11 12 Willis (Percy) Watson and Charles Lemuel (Charles) Young; and 13 WHEREAS, during their inaugural term of office, these representatives passed significant legislation, including the 14 15 State Employee Variable Comprehensive Plan and the 1982 Education 16 Reform Act; and WHEREAS, during the 1984-1988 legislative term, this group of 17 representatives passed legislation, including the largest pay 18 raise for teachers in the state at that time; a massive 19 20 reorganization of state boards and commissions, including 21

abolishment of the old Budget Commission, the Building Commission and Medicaid Commission; the Business Investment Act was hailed by economic development officials as a landmark piece of legislation to stimulate economic growth; and a major four-lane highway program was enacted despite a gubernatorial veto; and WHEREAS, legislation enacted during the term from 1988-1992

No. 165 99\HR40\R2111 PAGE 1 27 included the approval of a new Economic Development Highway Act to 28 help build roads for major industrial prospects; the approval of a 29 county-unit bill providing for people in each county to vote on a 30 centralized system of road management; the adoption of the equity 31 funding plan to assist local school districts and reduce financial 32 disparities among districts; the approval of the Economic 33 Development Reform Act to stimulate new business; and the replacement of the part-time State Parole Board with a full-time 34 35 five member board; and

36 WHEREAS, some highlights of the 1992-1996 legislative term 37 were: the Education Enhancement Act, the multi-million dollar 38 prison construction program, the Alcohol Boating Safety Act, the 39 establishment of the Department of Transportation and the creation 40 of the intermediate Court of Appeals; and

41 WHEREAS, since 1996, the Legislature has passed important 42 legislation such as the authorization of 32 new assistant district 43 attorneys around the state, the enactment of the Mississippi 44 Adequate Education Program, the approval of welfare laws to comply 45 with federal mandates, and the creation of the Mississippi Prepaid 46 Affordable College Tuition Program to help defray rising costs in 47 attending college; and

WHEREAS, it is the policy of this Legislature to 48 49 recognize and commend excellence, especially when evidenced by 50 such a remarkable group of individuals who came together to improve the quality of life for the citizens of Mississippi: 51 52 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE OF MISSISSIPPI, THE SENATE CONCURRING 53 54 THEREIN, That we do hereby commend the members of the House of Representatives who began their term in 1980 and are currently 55 serving the 1996-2000 term, for their outstanding service to the 56 57 people they represent and we extend to each member our heartiest wishes of success in all their future endeavors. 58
