HOUSE RESOLUTION NO. 8  
(As Adopted by House)

1 A RESOLUTION COMMENDING THE SCHOOL NURSES IN THE STATE OF  
2 MISSISSIPPI FOR THEIR OUTSTANDING SERVICE.

3 WHEREAS, school nurses will be recognized for their  
4 outstanding services during the Health Awareness Week on National  
5 School Nurse Day on January 27, 1999; and

6 WHEREAS, school nursing has existed in the United States for  
7 more than 100 years, and in 1969, Mary Haskell of Amory was the  
8 first certified school nurse in Mississippi; and

9 WHEREAS, school nurses promote and protect the health status  
10 of students and staff through health services and health education  
11 and by maintaining a healthy environment; and

12 WHEREAS, school nurses have a number of responsibilities,  
13 including screening students for hearing and vision problems,  
14 visiting students at home who are classified as homebound,  
15 providing staff development for communicable and contagious  
16 diseases, checking students for head lice, dental problems and  
17 scoliosis, identifying asthma, communicating with physicians or  
18 mental health care providers, providing and monitoring routine  
19 student medications, training students and staff on diabetes and  
20 providing sugar checks, and maintaining and implementing strategic  
21 plans for treating emergencies; and

22 WHEREAS, school nurses strengthen and facilitate the  
23 educational process by improving and protecting the health of  
24 children and staff by helping remove health-related barriers to  
25 the learning process for individual children; and

26 WHEREAS, school nurses collaborate with other education and

27 health care professionals to provide optimal school nursing care  
28 to the school community; and

29 WHEREAS, as of September 1997, the Mississippi Department of  
30 Education has employed 151 school nurses and currently, the state  
31 has approximately 170 school nurses in Mississippi's public  
32 schools; and

33 WHEREAS, school nurses contribute to the schools by: helping  
34 maintain a higher average daily attendance rate; providing a  
35 home-to-school connection for students with physical and mental  
36 problems; educating students, staff and community on health issues  
37 facing the classroom; preventing drug and/or alcohol abuse and  
38 intervening with students having such problems; and lowering  
39 teenage pregnancy through education; and

40 WHEREAS, the Legislature of the State of Mississippi finds it  
41 most appropriate to recognize such a remarkable group of people as  
42 the school nurses, who dedicate their lives to providing a safer,  
43 healthier school environment for the children of this state:

44 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF  
45 REPRESENTATIVES OF THE STATE OF MISSISSIPPI, That we do hereby  
46 commend the school nurses throughout the State of Mississippi and  
47 extend our deepest appreciation for the outstanding services they  
48 provide to our school children.
