- University of Mississippi in 1964 and his law degree from that 11

- in Lafayette County, is tied with only one other current member of 14
- 15 the House, Speaker Pro Tempore Robert Clark, for the most years of
- 16 continuous service; and
- 17 WHEREAS, throughout his long and distinguished legislative
- career, Representative Perry, Chairman of the Judiciary "A" 18
- 19 Committee, has held numerous positions of leadership, including
- 20 having served as former Chairman of the House Appropriations,
- Constitution and Municipalities Committees and as a long-time 21
- 22 member of the Joint Legislative Budget Committee; and
- 23 WHEREAS, under his outstanding leadership as Chairman of the
- 24 Appropriations Committee, the state General Fund budget grew from
- 25 Nine Hundred Seventy Million Dollars to over One Billion Six
- Hundred Million Dollars; and 26
- WHEREAS, Representative Perry has served as a member of 2.7

- 30 Joint Committee on Compilation, Revision and Publication of State
- 31 Legislation; a special committee to evaluate the medical
- 32 malpractice insurance program in the state; and study committees
- 33 on governmental reorganization, improving the state's educational
- 34 system and the need for an intermediate appeals court; and
- 35 WHEREAS, Representative Perry has been a strong advocate of
- 36 improving education, including the institutions of higher learning
- 37 and worked tirelessly to provide adequate funding for the state's
- 38 universities and related educational programs; and
- 39 WHEREAS, a leader in promoting law and order, Representative
- 40 Perry handled the legislation in 1996 to authorize 32 new
- 41 assistant district attorneys around the state and to provide for
- 42 additional criminal investigators in four districts; and
- WHEREAS, as a founding member of the Joint Legislative Budget
- 44 Committee, Representative Perry assisted the Legislature in
- 45 charting a new course of formulating our state's budget when a
- 46 court case about the separation of powers between the three
- 47 branches of government required a change in the process; and
- WHEREAS, through his dedication and progressive leadership,
- 49 Representative Perry has earned the respect of his fellow House
- 50 members and his congenial nature has had a positive influence on
- 51 all who have had the pleasure of working with him and hearing him
- 52 say in tense moments of the legislative process, "Now, let's all

- 55 skills and personal integrity, will leave a legacy of service, a
