SENATE BILL NO. 2153 (As Sent to Governor)

AN ACT TO CREATE THE METRO RECREATIONAL HIGHWAY AUTHORITY; TO 1 PROVIDE THAT THE MEMBERSHIP OF THE AUTHORITY SHALL CONSIST OF THE 2 3 MAYORS OF THE CITIES OF PEARL, FLOWOOD, RICHLAND AND JACKSON, OR THEIR DESIGNEES; TO PROVIDE THAT THE AUTHORITY SHALL STUDY THE 4 5 PORTIONS OF THE PEARL RIVER LEVEE SYSTEM LOCATED WITHIN THE CITY б LIMITS OF PEARL, FLOWOOD, RICHLAND AND JACKSON TO DETERMINE THE 7 FEASIBILITY AND DESIRABILITY OF UTILIZING THE EXISTING LEVEE 8 SYSTEM AS A LOCATION FOR A SYSTEM OF PUBLIC ROADS AND DEVELOPING 9 RECREATIONAL OPPORTUNITIES OF PUBLICLY OWNED LANDS BETWEEN THE 10 LEVEES LOCATED WITHIN THE MUNICIPAL LIMITS OF SUCH MUNICIPALITIES; TO PROVIDE THAT IF THE AUTHORITY DETERMINES THAT EITHER OF SUCH 11 USES ARE FEASIBLE AND DESIRABLE IT SHALL DEVELOP A PLAN TO 12 13 IMPLEMENT SUCH USES; AND FOR RELATED PURPOSES. BE IT ENACTED BY 14 THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

16 <u>SECTION 1.</u> (1) There is hereby created the Metro 17 Recreational Highway Authority (Authority). The membership of the 18 Authority shall consist of the mayors of the Cities of Pearl, 19 Flowood, Richland and Jackson, or their designee. The first meeting of the Authority shall be held by the Authority within 20 21 sixty (60) days after the passage of this act at a time and place agreed upon by the members of the Authority. At such meeting the 2.2 Authority shall select from among its membership a chairman and 23 such other officers as it considers necessary to conduct its 24 business. Any final action of the Authority shall require <u>a</u> 25 26 unanimous vote of its membership.

(2) The Authority shall study the Pearl River levee system
located within the municipal limits of the Cities of Pearl,
Flowood, Richland and Jackson and the publicly owned land between
such levees to determine the feasibility and desirability of:

(a) Utilizing the existing levee system as a location
for a system of public roads; and

33 (b) Developing recreational opportunities on publicly
34 owned lands between the levees that are located within the
35 municipal limits of such municipalities.

36 (3) If the Authority determines that either of such uses are 37 feasible and desirable it shall develop a plan to implement such 38 uses.

39 The Authority is authorized to call upon any and all (4) agencies of the State of Mississippi, or any political subdivision 40 thereof, to furnish such information, data and assistance as will 41 42 enable it to carry out its duties under the provisions of this section and all agencies of the State of Mississippi and its 43 44 political subdivisions are hereby directed to cooperate with the Authority and render such information, data aid and assistance as 45 46 may be requested by the Authority.

47 (5) The Authority shall have the power to enlist the 48 services of any agency, either public or private, or any 49 individual or educational institution, research organization, 50 foundation, or educational or civic organization for assistance in 51 accomplishing the purposes of this act, conducting research or 52 gathering information.

53 (6) The Authority is authorized and empowered to receive and 54 expend any funds appropriated to it by the Legislature and any 55 funds received from any other source in carrying out the 56 objectives and purposes of this act.

57 (7) The Authority shall utilize employees of the Cities of
58 Pearl, Flowood, Richland and Jackson to assist it in performing
59 its duties.

60 SECTION 2. This act shall take effect and be in force from 61 and after its passage.
