10	SECTION 1. Section 37-19-7, Mississippi Code of 1972, is

12	37-19-7. (1) The allowance in the minimum education program

15	teachers' salaries as provided in this subsection for the number

33	It is the intent of the Legislature that any state funds made
34	available for salaries of licensed personnel in excess of the
35	funds paid for such salaries for the 1986-1987 school year shall
36	be paid to licensed personnel pursuant to a personnel appraisal
37	and compensation system implemented by the State Board of
38	Education. The State Board of Education shall have the authority
39	to adopt and amend rules and regulations as are necessary to
40	establish, administer and maintain the system.
41	All teachers employed on a full-time basis shall be paid a
42	minimum salary in accordance with the above scale. However, no
43	school district shall receive any funds under this section for any
44	school year during which the local supplement paid to any
45	individual teacher shall have been reduced to a sum less than that

65 experience possessed by the person holding such license until such 66 person shall have twenty-five (25) years of teaching experience. 67 For teachers holding a Class A license, the minimum base pay specified in this subsection shall be increased by the sum of Four 68 69 Hundred Twenty-five Dollars (\$425.00) for each year of teaching experience possessed by the person holding such license until such 70 person shall have twenty-one (21) years of teaching experience. 71 72 The level of professional training of each teacher to be used 73 in establishing the salary allotment for the teachers for each 74 year shall be determined by the type of valid teacher's license issued to those teachers on or before October 1 of the current 75 76 school year. Prior to April 15 of any school year in which a teacher 77 meets the standard requirements, any licensed teacher who shall 78 have met the requirements and acquired a Master Teacher 79 80 certificate from the National Board for Professional Teaching 81 Standards and who is employed by a local school board or the State Board of Education as a teacher and not as an administrator shall 82 83 receive a salary supplement in the amount of Six Thousand Dollars 84 (\$6,000.00) plus fringe benefits in addition to any other 85 compensation to which the teacher may be entitled. The teacher shall be reimbursed one (1) time for the actual cost of completing 86 87 the process of acquiring the Master Teacher certificate, regardless of whether or not the process resulted in the award of 88 the Master Teacher certificate. 89 The local school district or any 90 private entity may pay the cost of completing the process of 91 acquiring the Master Teacher certificate for any teacher employed in the district, and such cost shall be reimbursed if the teacher 92 completes the process, regardless of whether or not the process 93 resulted in the award of the Master Teacher certificate. 94 95 salary supplements, fringe benefits and process reimbursement 96 shall be paid directly by the State Department of Education to the 97 local school district and shall be in addition to its minimum 98 education program allotments and not a part thereof in accordance

- 99 with regulations promulgated by the State Board of Education, and
- 100 subject to appropriation by the Legislature. Local school
- 101 districts shall not reduce the local supplement paid to any
- 102 teacher receiving such salary supplement, and the teacher shall
- 103 receive any local supplement to which teachers with similar
- 104 training and experience are otherwise entitled.
- 105 SECTION 2. This act shall take effect and be in force from
- 106 and after July 1, 1999.
