- 3 CERTAIN CIRCUMSTANCES, THE PROVISIONS OF THE MISSISSIPPI MOTOR
- 4 VEHICLE SAFETY INSPECTION LAW THAT REQUIRE THE DISPLAY OF A VALID
- 5 MOTOR VEHICLE INSPECTION CERTIFICATE; AND FOR RELATED PURPOSES.
- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 7 SECTION 1. Section 63-13-7, Mississippi Code of 1972, is
- 8 amended as follows:
- 9 63-13-7. (1) Except as provided in subsection (4) of this
- 10 section, the Commissioner of Public Safety shall, not more than
- 11 once each year, require that every motor vehicle, trailer,
- 12 semitrailer and pole trailer registered in this state be inspected
- 13 and that an official certificate of inspection and approval be
- 14 obtained for each such vehicle. Each such vehicle must display at
- 15 all times a certificate of inspection and approval duly issued for
- 16 such vehicle upon the lower left hand corner of the windshield
- 17 thereof or upon such vehicle in such position as to be visible
- 18 from the outside.
- 19 (2) Except as provided in subsection (4) of this section,
- 20 every motor vehicle registered in any other state and operated
- 21 over the highways of this state shall be inspected and shall
- 22 display an inspection certificate which shall be different either
- 23 in color or design from the inspection certificates issued for use
- 24 on state registered vehicles.
- 25 However, the Commissioner of Public Safety may authorize the
- 26 acceptance in this state of a certificate of inspection and
- 27 approval issued under the authority of a qualified agency or

- 28 department of another state, provided that every municipality,
- 29 county and state office in such other state accepts under a
- 30 mutually acceptable reciprocal agreement, Mississippi's
- 31 certificate of inspection and approval. The commissioner shall
- 32 except from the provisions of this chapter all passenger buses and
- 33 other vehicles certified by the <u>United States Department of</u>
- 34 Transportation and subject to its rules and regulations and its
- 35 periodical inspections.
- 36 (3) The Commissioner of Public Safety shall require all
- 37 school buses in the State of Mississippi to be inspected during
- 38 the months of July or August each year and may provide such
- 39 special certificate of inspection and approval as he may deem
- 40 necessary.
- 41 (4) A motor vehicle manufactured or having a model year
- 42 earlier than 1961 shall not be required to be inspected or to
- 43 display a certificate of inspection under the provisions of this
- 44 chapter.
- 45 (5) In addition to members of the Mississippi Highway Safety
- 46 Patrol, all law enforcement officers of incorporated
- 47 <u>municipalities of this state, within their respective</u>
- 48 jurisdiction, may enforce the provisions of this chapter that
- 49 require the display of a valid motor vehicle inspection
- 50 <u>certificate; provided, however, that a municipal law enforcement</u>
- 51 officer shall not stop a motor vehicle for a violation of this
- 52 chapter, or charge an individual with a violation of this chapter,
- 53 <u>unless the motor vehicle is stopped as a result of some other</u>
- offense.
- 55 SECTION 2. This act shall take effect and be in force from
- 56 and after its passage.
