## SENATE BILL NO. 2256 (As Sent to Governor)

AN ACT TO AMEND SECTION 75-74-9, MISSISSIPPI CODE OF 1972, TO RECONSTITUTE THE YOUTH CAMP ADVISORY COUNCIL WITHIN THE STATE 2 3 BOARD OF HEALTH; TO REPEAL SECTION 75-74-13, MISSISSIPPI CODE OF 4 1972, WHICH PROVIDES FOR THE WAIVER OF COMPLIANCE WITH YOUTH CAMP RULES AND REGULATIONS; AND FOR RELATED PURPOSES. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 5 б 7 8 SECTION 1. Section 75-74-9, Mississippi Code of 1972, is 9 amended as follows: 75-74-9. (1) The State Board of Health shall have the 10 authority and the duty to make and promulgate rules and 11 regulations consistent with the policy and purpose of this 12 chapter, and to amend any rule or regulation it makes. In 13 14 developing such rules and regulations, the board shall consult 15 with appropriate public and private officials and organizations and parents and camp operators. It shall be the duty of the board 16 17 to advise all existing youth camps in this state of this chapter and any rules and regulations promulgated under this chapter. 18 (2) There is created within the State Board of Health the 19 advisory council on youth camp safety to advise and consult on 20 policy matters relating to youth camp safety \* \* \*. The council 21 22 consists of the health officer or his representative \* \* \* and a 23 minimum of eight (8) members appointed by the State Health 24 Officer, including the following groups: one (1) member 25 representative each from a private nonsectarian camp, a church-related or sponsored camp, the Girl Scouts of \* \* \* 26 America, the Boy Scouts of America, \* \* \* the Mississippi Camping 27 28 Association, camps for the handicapped and civic organization

- 29 camps; and a consumer, a parent or an older youth with prior
- 30 camping experience \* \* \*. A member is entitled to hold office for
- 31 two (2) years or until his successor is appointed and qualifies.
- 32 The State Health Officer or his representative shall fill
- 33 vacancies for unexpired terms. Council members serve without
- 34 compensation, but are entitled to be reimbursed for actual
- 35 expenses incurred in the performance of their duties. The State
- 36 Health Officer may appoint special advisory or technical experts
- 37 and consultants as are necessary to assist the council in carrying
- 38 out its functions.
- 39 (3) No rule or regulation promulgated or amended by the
- 40 board under this chapter shall be effective until a public hearing
- 41 is held thereon \* \* \*. Notice of a public hearing, including the
- 42 time, date and location of the hearing and the substance of the
- 43 proposed rule, regulation or amendment, shall be given by the
- 44 board to each licensee of a youth camp and the general public not
- 45 less than ten (10) days nor more than thirty (30) days before the
- 46 hearing. Any interested person may appear at the hearing to
- 47 present evidence or testimony concerning the proposed rule,
- 48 regulation or amendment.
- 49 SECTION 2. Section 75-74-13, Mississippi Code of 1972, which
- 50 provides for a waiver of compliance with youth camp rules and
- 51 regulations, is repealed.
- 52 SECTION 3. This act shall take effect and be in force from
- 53 and after July 1, 1999.
