SENATE BILL NO. 2303 (As Sent to Governor)

1 AN ACT TO AMEND SECTION 25-3-43, MISSISSIPPI CODE OF 1972, TO 2 PROVIDE THAT JUSTICES OF THE SUPREME COURT AND JUDGES OF THE COURT 3 OF APPEALS SHALL RECEIVE A DAILY EXPENSE ALLOWANCE IN THE SAME 4 AMOUNT AS THE FEDERAL EXPENSE ALLOWANCE RATE, WHICH SHALL BE IN 5 ADDITION TO THEIR REGULAR SALARY AND MILEAGE REIMBURSEMENT; TO 6 AMEND SECTION 9-4-13, MISSISSIPPI CODE OF 1972, IN CONFORMITY 7 THERETO; AND FOR RELATED PURPOSES.

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 9 SECTION 1. Section 25-3-43, Mississippi Code of 1972, is 10 amended as follows:

25-3-43. (1) When any chancery judge, county judge or 11 circuit judge shall be required to travel in the performance of 12 his official duties, such judge shall receive as expenses of such 13 14 travel the mileage allowance and a reimbursement for other actual 15 and necessary expenses incurred in such travel as provided for public officers and employees in Section 25-3-41, Mississippi Code 16 of 1972. This shall be the entire travel allowances or travel 17 expenses received by such judges. 18

(2) Chancery judges and circuit judges shall direct requests
for reimbursement for the travel expenses authorized pursuant to
this section to the Supreme Court and the Supreme Court shall
submit such requests to the Department of Finance and

23 Administration.

(3) The Supreme Court shall have the power to adopt rules
and regulations regarding the administration of travel expenses
authorized pursuant to this section.

(4) In any county in which is located a State Penitentiary,the board of supervisors, in order to compensate the justice court

No. 2303 99\SS02\R377SG PAGE 1 judges who are required to travel to the State Penitentiary, is authorized to reimburse justice court judges' mileage in the amount authorized by Section 25-3-41, but not to exceed One Hundred Dollars (\$100.00) per month, such monies to be paid from the general county fund of such county.

34 (5) In addition to the regular salary provided by Section 25-3-35 and the mileage reimbursement provided by Section 25-3-41, 35 36 each Supreme Court Justice and each judge of the Court of Appeals shall receive an expense allowance as specified in this 37 subsection. The expense allowance shall be equal to the maximum 38 39 daily expense rate allowable to employees of the federal 40 government for travel in the high rate geographical area of 41 Jackson, Mississippi, as may be established by federal regulations, per day, for each day while actually attending to 42 judicial duties in Jackson, Mississippi, not to exceed twenty (20) 43 44 days per month. SECTION 2. Section 9-4-13, Mississippi Code of 1972, is 45

46 amended as follows:

9-4-13. (1) The judges of the Court of Appeals shall receive salaries as provided for in Section 25-3-35, shall be reimbursed for <u>mileage</u> expenses incurred in performing their duties at the rate authorized by law for public officials and employees as provided <u>for in Section 25-3-41</u>, and shall receive an <u>expense allowance as provided for in Section 25-3-43</u>.

53 (2) Staff attorneys, law clerks and all other employees of
54 the Court of Appeals shall be of the same grade classification as
55 Supreme Court employees performing the same or similar duties.

56 SECTION 3. The Attorney General of the State of Mississippi 57 shall submit this act, immediately upon approval by the Governor, 58 or upon approval by the Legislature subsequent to a veto, to the 59 Attorney General of the United States or to the United States 60 District Court for the District of Columbia in accordance with the 61 provisions of the Voting Rights Act of 1965, as amended and 62 extended.

63 SECTION 4. This act shall take effect and be in force from 64 and after July 1, 1999, or the date it is effectuated under 65 Section 5 of the Voting Rights Act of 1965, as amended and
