1 2 3 4	AN ACT TO AMEND SECTION 73-21-108, MISSISSIPPI CODE OF 1972, TO EXTEND THE REPEALER ON THE STATUTE PRESCRIBING PERMIT REQUIREMENTS FOR PERSONS PROVIDING HOME MEDICAL EQUIPMENT; AND FOR RELATED PURPOSES.
5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
6	SECTION 1. Section 73-21-108, Mississippi Code of 1972, is
7	amended as follows:
8	73-21-108. (1) Definitions. For the purposes of this
9	section:
10	(a) "Home medical equipment" means technologically
11	sophisticated medical equipment and devices usable in a home care
12	setting, including, but not limited to:
13	(i) Oxygen for human consumption, oxygen
14	concentrators and/or oxygen delivery systems and equipment;
15	(ii) Ventilators;
16	(iii) Respiratory disease management devices;
17	(iv) Electronic and computer driven wheelchairs
18	and seating systems;
19	(v) Apnea monitors;
20	(vi) Transcutaneous electrical nerve stimulator
21	(TENS) units;
22	(vii) Low air loss cutaneous pressure management
23	devices;
24	(viii) Sequential compression devices;
25	(ix) Neonatal home phototherapy devices;
26	(x) Feeding pumps; and
27	(xi) Other similar equipment as defined in

- 28 regulations adopted by the board.
- 29 The term "home medical equipment" does not include medical
- 30 equipment used in the normal course of treating patients by
- 31 hospitals, hospices, long-term care facilities or home health
- 32 agencies, or medical equipment used or dispensed by health care
- 33 professionals licensed by the State of Mississippi if the
- 34 professional is practicing within the scope of his or her
- 35 professional practice. In addition, the term does not include
- 36 items such as upper and lower extremity prosthetics, canes,
- 37 crutches, walkers, bathtub grab bars, standard wheelchairs,
- 38 commode chairs and bath benches.
- 39 (b) "Home medical equipment services" means the
- 40 delivery, installation, maintenance, replacement, and/or
- 41 instruction in the use of home medical equipment, used by a sick
- 42 or disabled individual, to allow the individual to be cared for
- 43 and maintained in a home or noninstitutional environment.
- 44 (c) "Medical gas" means those gases and liquid oxygen
- 45 intended for human consumption.
- 46 (d) "Order" means an order issued by a licensed
- 47 practitioner legally authorized to order home medical equipment
- 48 and/or medical gases.
- 49 (2) **Permit required.** (a) No person, business or entity
- 50 located in this state or outside of this state that is subject to
- 51 this section shall sell, rent or provide or offer to sell, rent or
- 52 provide directly to patients in this state any home medical
- 53 equipment, legend devices, and/or medical gas unless such person,
- 54 business or entity first obtains a Medical Equipment Supplier
- 55 Permit from the board.
- 56 (b) The permitting requirements of this section apply
- 57 to all persons, companies, agencies and other business entities
- 58 that are in the business of supplying home medical equipment to
- 59 patients in their places of residence and that bill the patient or
- 60 the patient's insurance, Medicare, Medicaid or other third party

- 61 payor for the rent or sale of that equipment.
- 62 (c) The board shall require a separate permit for each
- 63 facility location directly or indirectly owned or operated in this
- 64 state.
- (d) The application for a permit shall be made to the
- 66 board on a form supplied by the board and shall be accompanied by
- 67 a fee of not more than Three Hundred Dollars (\$300.00), as
- 68 prescribed by the board. Once issued, every permit must be
- 69 renewed annually, and the renewal fee shall be not more than One
- 70 Hundred Seventy-five Dollars (\$175.00), as prescribed by the
- 71 board.
- 72 (e) All permits issued under this section shall expire
- 73 annually on June 30 of each year. Applications for renewal must
- 74 be made to the board on or before June 30 and must be accompanied
- 75 by the fee as prescribed by the board. A late renewal fee of One
- 76 Hundred Dollars (\$100.00) shall be added to all renewal
- 77 applications received by the board after June 30 of each renewal
- 78 period. The permit shall become void if the renewal application,
- 79 renewal fee and the late renewal fee are not received by the board
- 80 by September 30 of each year.
- 81 (3) **Exemptions.** (a) The permitting requirements of this
- 82 section do not apply to the following entities or practitioners
- 83 unless they have a separate business entity, company, corporation
- 84 or division that is in the business of providing home medical
- 85 equipment for sale or rent to patients at their places of
- 86 residence:
- 87 (i) Home health agencies;
- 88 (ii) Hospitals;
- 89 (iii) Wholesalers and/or manufacturers;
- 90 (iv) Medical doctors, physical therapists,
- 91 respiratory therapists, occupational therapists, speech
- 92 pathologists, optometrists, chiropractors and podiatrists who use
- 93 home medical equipment and/or legend devices in their individual

- 94 practices;
- 95 (v) Pharmacies;
- 96 (vi) Hospice programs;
- 97 (vii) Nursing homes and/or long-term care
- 98 facilities;
- 99 (viii) Veterinarians; dentists; and emergency
- 100 medical services.
- 101 (b) Although community pharmacies are exempt from the
- 102 permitting requirements of this section, they shall be subject to
- 103 the same regulations that are applicable to permitted businesses
- 104 or entities for the sale or rental of home medical equipment
- 105 covered by this section.
- 106 (c) Nothing in this section shall prohibit trained
- 107 individuals from using oxygen, liquid oxygen and/or legend devices
- 108 in emergencies.
- 109 (d) Nothing in this section shall prohibit the
- 110 prehospital emergency administration of oxygen by licensed health
- 111 care providers, emergency medical technicians, first responders,
- 112 fire fighters, law enforcement officers and other emergency
- 113 personnel trained in the proper use of emergency oxygen.
- 114 (4) Order required. Home medical equipment suppliers shall
- 115 not provide any home medical equipment to a patient without a
- 116 valid order from an authorized licensed practitioner.
- 117 (5) Regulations. The board shall adopt regulations for the
- 118 distribution and sale or rental of home medical equipment, legend
- 119 devices and medical gases that promote the public health and
- 120 welfare and comply with at least the minimum standards, terms and
- 121 conditions of federal laws and regulations. The regulations shall
- 122 include, without limitation:
- 123 (a) Minimum information from each home medical
- 124 equipment, legend device and medical gas supplier required for
- 125 permitting and renewal permits;
- 126 (b) Minimum qualifications of persons who engage in the

- 127 distribution of home medical equipment;
- 128 (c) Appropriate education, training or experience of
- 129 persons employed by home medical equipment suppliers;
- (d) Minimum standards for storage of home medical
- 131 equipment;
- (e) Minimum requirements for the establishment and
- 133 maintenance of all records for the sale, rental and servicing of
- 134 home medical equipment; and
- (f) Minimum standards of operation and professional
- 136 conduct.
- 137 (6) Medical Equipment Advisory Committee to the board.
- 138 (a) A Medical Equipment Advisory Committee (MEAC),
- 139 composed of three (3) members selected by the Mississippi
- 140 Association of Medical Equipment Suppliers and approved by the
- 141 board, shall review and make recommendations to the board
- 142 regarding all regulations dealing with home medical equipment,
- 143 legend devices and medical gases that are proposed by the board
- 144 and before they are adopted by the board.
- 145 (b) All MEAC members must have been actively involved
- 146 in the home medical equipment business for a minimum of five (5)
- 147 years before the selection to the committee and shall hold and
- 148 maintain, in good standing, a permit issued by the board under
- 149 this section.
- 150 (c) The MEAC members shall meet at least quarterly and
- 151 review all home medical equipment suppliers' inspection reports.
- 152 All complaints and reports of investigations of violations of law
- 153 or regulations regarding home medical equipment, legend devices
- 154 and medical gases shall first be reviewed by the MEAC. After
- 155 review, the MEAC may make recommendations to the board's
- 156 Investigations Review Committee regarding further administrative
- 157 action by the board.
- 158 (d) The MEAC shall keep and maintain minutes of all
- 159 meetings of the MEAC and shall provide copies of the minutes to

- 160 the board on a quarterly basis.
- 161 (7) Revocation, Suspension or Restriction of Permit and
- 162 Penalties.
- 163 (a) The board may revoke, suspend, restrict or refuse
- 164 to issue or renew a permit or impose a monetary penalty, in
- 165 accordance with Section 73-21-103 except that the monetary penalty
- 166 shall not exceed Ten Thousand Dollars (\$10,000.00) per violation,
- 167 if the business or holder of a permit or applicant for a permit
- 168 issued under this section has committed or is found guilty by the
- 169 board of any of the following:
- 170 (i) Violation of any federal, state or local law
- 171 or regulations relating to home medical equipment, legend devices
- 172 or medical gases.
- 173 (ii) Violation of any of the provisions of this
- 174 section or regulations adopted under this section.
- 175 (iii) Commission of an act or engaging in a course
- 176 of conduct that constitutes a clear and present danger to the
- 177 public health and safety.
- 178 (iv) Filing a claim or assisting in the filing of
- 179 a claim for reimbursement for home medical equipment or home
- 180 medical equipment services that were not provided or that were not
- 181 authorized to be provided.
- 182 (v) Failure to comply with any lawful order of the
- 183 board.
- (b) Disciplinary action by the board against a business
- 185 or any person holding a permit under this section shall be in
- 186 accordance with Section 73-21-99.
- 187 (8) Repealer. This section shall stand repealed on July 1,
- 188 <u>2001</u>.
- 189 SECTION 2. This act shall take effect and be in force from
- 190 and after June 30, 1999.
