SENATE BILL NO. 2326 (As Passed the Senate)

AN ACT TO DIRECT THE DEPARTMENT OF FINANCE AND ADMINISTRATION 1 2 TO SELL AND CONVEY TO BELHAVEN COLLEGE CERTAIN PARCELS OF PROPERTY 3 FRONTING THE NORTH SIDE OF RIVERSIDE DRIVE AND THE SOUTH SIDE OF WOODROW WILSON AVENUE IN JACKSON, MISSISSIPPI, AND LYING EAST AND 4 5 NORTH AND NORTHWEST OF PROPERTY OWNED BY THE SALVATION ARMY; AND 6 FOR RELATED PURPOSES. 7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: SECTION 1. (1) The Department of Finance and 8 9 Administration, upon meeting the requirements of Section 29-1-1, 10 shall sell and convey to Belhaven College two parcels of property 11 fronting the north side of Riverside Drive in Jackson, Hinds County, Mississippi, and the south side of Woodrow Wilson Avenue 12 13 in Jackson, Hinds County, Mississippi, and lying north and east and northwest of the property owned by the Salvation Army, the 14 property being more particularly described as follows: 15 Parcel A 16 A certain parcel of land being situated in the Northwest 17 18 1/4 of the Northeast 1/4 of Section 35, T6N-R1E, City of Jackson, Hinds County, Mississippi, and being more 19 20 particularly described as follows: 21 Commence at an iron pin marking the Point of Intersection of the North right-of-way line of Riverside Drive with 22 23 the East right-of-way line of Murrah Drive (as both are now laid out and improved); run thence North 89 degrees 24 25 47 minutes 20 seconds East along said North right-of-way 26 line of Riverside Drive for a distance of 700.00 feet to the Southwest corner of a 5.964 acre tract of land 27 (Belhaven College); leaving said North right-of-way line 28

The Department of Finance and Administration may have the parcels 131 132 of property surveyed in order to determine the specific legal description, but the total property conveyed shall not exceed 133 134 thirteen (13) acres. It is expressly provided that Belhaven 135 College shall have five (5) years from the date of this act to 136 purchase all or part of the property and may do so by purchasing 137 the property in two (2) separate parcels of at least five (5) acres each during the five-year period. 138

(2) The real property described in subsection (1) of this section shall be sold for not less than the current fair market value as determined by the averaging of at least two (2) appraisals by qualified appraisers who shall be selected by the Department of Finance and Administration and shall be certified and licensed by the Mississippi Real Estate Appraiser Licensing and Certification Board.

146 (3) Any funds received by the State of Mississippi for the 147 conveyance of the real property described in subsection (1) of 148 this section shall be deposited into the State General Fund.

149 (4) The State of Mississippi shall retain all mineral rights150 to the real property sold pursuant to this section.

151 SECTION 2. This act shall take effect and be in force from 152 and after its passage.
