1 2 3	AN ACT TO AMEND CHAPTER 478, GENERAL LAWS OF 1998, TO EXTEND THE LIFE OF THE JOINT NATURAL AND SCENIC RIVER STUDY COMMITTEE FOR ONE YEAR; AND FOR RELATED PURPOSES.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI
5	SECTION 1. Chapter 478, General Laws of 1998, is amended as
6	follows:
7	Section 1. (1) There is hereby created a natural and scenic
8	river study committee. The committee shall consist of the
9	following members: (a) the Chairman of the House Game and Fish
10	Committee and two (2) members of the Game and Fish Committee
11	appointed by the chairman; the Chairman of the House Conservation
12	and Water Resources Committee and two (2) members of the
13	Conservation and Water Resources Committee appointed by the
14	chairman; the Chairman of the House Agriculture Committee and two
15	(2) members of the Agriculture Committee appointed by the
16	chairman; and (b) the Chairman of the Senate Wildlife and
17	Fisheries Committee and two (2) members of the Wildlife and
18	Fisheries Committee appointed by the chairman; the Chairman of the
19	Senate Environmental Protection, Conservation and Water Resources
20	Committee and two (2) members of the Environmental Protection,
21	Conservation and Water Resources appointed by the chairman; the
22	Chairman of the Senate Agriculture Committee and two (2) members
23	of the Agriculture Committee appointed by the chairman. $\underline{\text{The}}$
24	committee is hereby created, continued and reconstituted and shall
25	continue to function until it is dissolved under subsection (5).
26	The Chairman of the House Game and Fish Committee and the

- 27 Chairman of the Senate Wildlife, Fisheries and Parks Committee
- 28 shall serve as cochair of the study committee.
- 29 For attending meetings of the committee, each legislative
- 30 member shall be paid per diem in the amount authorized by Section
- 31 25-3-69 and a mileage allowance and an expense allowance in the
- 32 amount authorized by Section 5-1-47 from the contingent expense
- 33 fund of his respective house. However, no per diem, mileage
- 34 allowance or expense allowance shall be paid for attending
- 35 meetings of the committee while the Legislature is in session, and
- 36 no per diem, mileage allowance or expense allowance shall be paid
- 37 without prior approval of the proper committee in the member's
- 38 respective house.
- 39 (2) In conducting its activities, the committee may elicit
- 40 the support of and participation by any commercial, industrial,
- 41 governmental, environmental, minority and public interest
- 42 organizations and associations, or individual members thereof, and
- 43 any federal, state and local agencies and political subdivisions
- 44 as may be necessary or appropriate in the furtherance of the
- 45 study.
- 46 (3) The Department of Wildlife, Fisheries and Parks shall
- 47 coordinate the study of certain natural and scenic rivers in the
- 48 state. The study shall be conducted in order to assess and
- 49 document the ecological, scenic, recreational and natural
- 50 characteristics of these rivers; to consider the feasibility of a
- 51 program for conserving the quality of scenic rivers; to recommend
- 52 a plan of nonregulatory incentive programs to encourage landowner
- 53 participation in any stream protection program that may be
- 54 recommended; to ensure any activities on a natural and scenic
- 55 river shall be according to best management practices; to ensure
- 56 that any natural and scenic river program shall be administered
- 57 solely by the State of Mississippi.
- 58 (4) The committee shall seek public oral and written
- 59 comments on the scenic rivers.

- 60 (5) The committee shall prepare a report of the study with
- 61 recommendations and file the report with the Legislature by
- 62 <u>January 4, 2000</u>. Upon presentation of its report to the
- 63 Legislature, the committee shall be dissolved.
- (6) For purpose of the study, a "natural and scenic river"
- 65 means a river, stream or bayou or segment thereof that is in a
- 66 free-flowing condition, that has not been channelized, cleared and
- 67 snagged within the past five (5) years, realigned, inundated or
- 68 otherwise altered and has a shoreline covered by native vegetation
- 69 and has no or few man-made structures along its banks.

- 71 and after its passage.
