1 AN ACT TO AMEND SECTION 9-19-7, MISSISSIPPI CODE OF 1972, TO
2 SET THE SALARY OF THE EXECUTIVE DIRECTOR AND SENIOR STAFF ATTORNEY
3 OF THE COMMISSION ON JUDICIAL PERFORMANCE; TO AMEND SECTION
4 25-3-33, MISSISSIPPI CODE OF 1972, TO DELETE THE SALARY OF THE
5 EXECUTIVE DIRECTOR OF THE COMMISSION ON JUDICIAL PERFORMANCE FROM
6 SAID SECTION; TO REVISE THE SALARY OF THE EXECUTIVE DIRECTOR OF
7 THE PEARL RIVER VALLEY WATER SUPPLY DISTRICT; TO AMEND SECTION
8 37-3-9, MISSISSIPPI CODE OF 1972, TO PROVIDE THAT THE STATE
9 SUPERINTENDENT OF EDUCATION SHALL RECEIVE AN ANNUAL SALARY
10 PRESCRIBED BY THE STATE BOARD OF EDUCATION; AND FOR RELATED
11 PURPOSES.

12 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

13 SECTION 1. Section 9-19-7, Mississippi Code of 1972, is
14 amended as follows:

15 9-19-7. The commission may appoint and remove an executive
16 director and such administrative staff as may be required. The
17 salary of the executive director shall be the same as that of a
18 district attorney; the salary of the senior staff attorney shall
19 be the same as the maximum allowed for an assistant district
20 attorney. This staff shall report each charge filed to the
21 commission.

22 SECTION 2. Section 25-3-33, Mississippi Code of 1972, is
23 amended as follows:

24 25-3-33. The annual salaries of the following appointive
25 state and district officials and employees are fixed as follows:

26 Deputy Attorney General, not to exceed..... \$72,800.00

27 Assistant Attorneys General shall each

28 receive annual salaries in an amount

155 SECTION 3. Section 37-3-9, Mississippi Code of 1972, is
156 amended as follows:

157 37-3-9. (1) * * * From and after July 1, 1984, there shall
158 be a State Superintendent of Public Education who shall be
159 appointed by the State Board of Education, with the advice and
160 consent of the Senate, and serve at the board's will and pleasure.

161 He shall be the chief administrative officer for the State
162 Department of Education and shall administer the department in
163 accordance with the policies established by the State Board of
164 Education. He shall receive such compensation as shall be
165 prescribed by the State Board of Education. The State
166 Superintendent of Public Education shall have at least a master's
167 degree in any field and a minimum of five (5) years' experience in

168 administration in the educational field.

169 (2) The state superintendent shall give bond in the penalty
170 of Seventy-five Thousand Dollars (\$75,000.00), with sureties to be
171 approved by the Governor, conditioned according to law. Said bond
172 when approved shall be filed and recorded in the office of the
173 Secretary of State.

174 SECTION 4. This act shall take effect and be in force from
175 and after July 1, 1999.
