SENATE BILL NO. 2479

1 AN ACT TO AMEND SECTION 9-19-7, MISSISSIPPI CODE OF 1972, TO
2 SET THE SALARY OF THE EXECUTIVE DIRECTOR AND SENIOR STAFF ATTORNEY
3 OF THE COMMISSION ON JUDICIAL PERFORMANCE; TO AMEND SECTION
4 25-3-33, MISSISSIPPI CODE OF 1972, TO DELETE THE SALARY OF THE
5 EXECUTIVE DIRECTOR OF THE COMMISSION ON JUDICIAL PERFORMANCE FROM
6 SAID SECTION; TO REVISE THE SALARY OF THE EXECUTIVE DIRECTOR OF
7 THE PEARL RIVER VALLEY WATER SUPPLY DISTRICT; AND FOR RELATED
8 PURPOSES.

9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

10 SECTION 1. Section 9-19-7, Mississippi Code of 1972, is
11 amended as follows:

12 9-19-7. The commission may appoint and remove an executive
13 director and such administrative staff as may be required. The
14 salary of the executive director shall be the same as that of a
15 district attorney; the salary of the senior staff attorney shall
16 be the same as the maximum allowed for an assistant district
17 attorney. This staff shall report each charge filed to the
18 commission.

19 SECTION 2. Section 25-3-33, Mississippi Code of 1972, is
20 amended as follows:

21 25-3-33. The annual salaries of the following appointive
22 state and district officials and employees are fixed as follows:
