COMMITTEE SUBSTITUTE FOR SENATE BILL NO. 2612

AN ACT TO AMEND SECTION 19-3-13, MISSISSIPPI CODE OF 1972, TO 1 PROVIDE THAT IN COUNTIES HAVING TWO COURT DISTRICTS AND A CERTAIN 3 POPULATION IN WHICH THE BOARD OF SUPERVISORS OF THE COUNTY HAS ELECTED TO HAVE TWO REGULAR MEETINGS EACH MONTH, THE PLACE FOR 5 HOLDING SUCH MEETINGS MAY BE IN EITHER OF SUCH DISTRICTS OR MAY BE ALTERNATED BETWEEN EACH OF THE TWO DISTRICTS; AND FOR RELATED 6 7 PURPOSES. 8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 9 SECTION 1. Section 19-3-13, Mississippi Code of 1972, is 10 amended as follows: 19-3-13. In counties having two (2) court districts, the 11 board of supervisors shall hold regular meetings on the first 12 Monday of each month; and in such counties where only one (1) 13 14 regular meeting of the board of supervisors is held in each month, 15 the board of supervisors shall hold its first meeting in each year at the courthouse or in the chancery clerk's office, where the 16 chancery clerk's office is in a building separate from the 17 courthouse, of the first district, on the first Monday of January, 18 and shall hold its second meeting at the courthouse or in the 19 chancery clerk's office, where the chancery clerk's office is in a 20 building separate from the courthouse, of the second district, on 21 22 the first Monday of February, and shall alternate thereafter. In counties having two (2) court districts, the board of 23 24 supervisors may hold two (2) regular meetings in each month, and in such counties, where the board of supervisors elects to hold 25 two (2) regular meetings in each month, the board of supervisors 26 shall hold its first meeting in each month at the courthouse or in 27 28 the chancery clerk's office, where the chancery clerk's office is

29 in a building separate from the courthouse, of the first district,
```

- 30 on the first Monday of each month, and shall hold its second
- 31 meeting at the courthouse or in the chancery clerk's office, where
- 32 the chancery clerk's office is in a building separate from the
- 33 courthouse, of the second district, on the second Monday of each
- 34 month.
- If the board of supervisors in any such county shall elect to
- 36 hold two (2) regular meetings in each month, as herein provided,
- 37 the board shall enter an order upon its minutes to that effect and
- 38 shall give at least five (5) days' notice thereof by posting
- 39 copies of such notice at the courthouse door of each district, and
- 40 after giving such notice the board shall hold regular meetings
- 41 each month in each district as provided in this section.
- However, in counties having two (2) court districts where the
- 43 board of supervisors has heretofore pursuant to law elected to
- 44 hold two (2) regular meetings a month, the board of supervisors
- 45 may continue to hold two (2) such regular meetings each month, as
- 46 heretofore provided for, and no further order or notice of such
- 47 meetings shall be required.
- Moreover, in those counties having two (2) judicial
- 49 districts, where the act creating the two (2) districts provides
- 50 otherwise, the board of supervisors may continue to hold regular
- 51 meetings as required by the act creating the two (2) districts.
- In any county having two (2) court districts and a population
- 53 in excess of two hundred thousand (200,000) according to the
- 54 <u>federal decennial census of 1970, the board of supervisors shall</u>
- 55 hold regular meetings on the first Monday of each month and may
- 56 <u>elect to hold an additional regular meeting on the second Monday</u>
- 57 of each month. The meetings shall be held at the courthouse in
- 58 the first or second district or, where the chancery clerk's office
- 59 <u>is in a building separate from the courthouse, in the chancery</u>
- 60 clerk's office of that district. The board of supervisors, in its
- 61 <u>discretion</u>, may alternate such meetings between the first and
- 62 second districts or may hold all such meetings in only one (1) of
- 63 <u>such districts.</u>
- If the board of supervisors in any such county elects to hold
- 65 two (2) regular meetings in each month, as herein provided, the

- 66 board shall enter an order upon its minutes to that effect and
- 67 shall give at least five (5) days' notice thereof by posting
- 68 copies of such notice at the courthouse door of each district.
- When any such meeting date falls on a legal holiday, then the
- 70 said meeting shall be held on the succeeding day.
- 71 SECTION 2. This act shall take effect and be in force from
- 72 and after July 1, 1999.
