## SENATE BILL NO. 2645 (As Passed the Senate)

AN ACT MAKING AN ADDITIONAL APPROPRIATION OF STATE GENERAL 1 FUNDS TO THE STATE TAX COMMISSION FOR THE PURPOSE OF REIMBURSING 3 THE COUNTIES, COUNTY DISTRICTS AND MUNICIPAL SEPARATE SCHOOL DISTRICTS FOR TAX LOSSES INCURRED BY REASON OF THE EXEMPTION OF 5 HOMES FROM CERTAIN AD VALOREM TAXES FOR FISCAL YEAR 1999. 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 7 SECTION 1. In addition to all other sums heretofore appropriated, the following sum, or so much thereof as may be 9 necessary, is hereby appropriated out of any money in the State 10 General Fund not otherwise appropriated, to the State Tax 11 Commission for the purpose of reimbursing the counties of the state, the road districts and school districts therein and the 12 13 municipal separate school districts, for tax losses incurred by 14 reason of the exemption of homes from certain ad valorem taxes under the provisions of Section 27-33-1 et seq., Mississippi Code 15 of 1972, for the fiscal year ending June 30, 1999...... 16 17 .....\$ SECTION 2. Each county, road district, school district and 18 municipal separate school district which has incurred a tax loss 19 that is reimbursable under Section 1 shall be reimbursed a sum 20 21 which is equivalent to the amount of tax loss produced by the application of tax rates annually fixed for maintenance and 22 23 current expenses to the assessed value of homes, or so much thereof as has been lawfully authorized under the provisions of 2.4 Section 27-33-1 et seq., Mississippi Code of 1972. 25 The disbursements from this appropriation shall be based upon 26 the certificates required of the clerks of the county boards of 2.7

- 28 supervisors and of the clerks of the municipalities, which
- 29 certificates shall conform strictly in every respect to the
- 30 requirements of the provisions of Section 27-33-1 et seq.,
- 31 Mississippi Code of 1972.
- 32 All disbursements from this appropriation shall be made
- 33 strictly in accordance with the provisions of Section 27-33-1 et
- 34 seq., Mississippi Code of 1972, and no disbursements other than
- 35 those clearly authorized by those sections shall be made, the
- 36 provisions of any other law to the contrary notwithstanding.
- 37 SECTION 3. The money herein appropriated shall be paid by
- 38 the State Treasurer out of any money in the proper fund or funds
- 39 as set forth in this act, upon warrants issued by the State Fiscal
- 40 Officer; and the State Fiscal Officer shall issue his warrants
- 41 upon requisitions signed by the proper person, office or officers
- 42 in the manner provided by law.
- 43 SECTION 4. This act shall take effect and be in force from
- 44 and after its passage.
