- 3 PREPARE LICENSES FOR THE PRIVILEGES TAXED PURSUANT TO CHAPTER 80,
- 4 LAWS OF 1902, AND RECEIVE PAYMENTS FOR SUCH LICENSES; AND FOR
- 5 RELATED PURPOSES.
- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 7 SECTION 1. Chapter 80, Laws of 1902, is amended as follows:
- 8 Section 1. The Board of Levee Commissioners for the
- 9 Yazoo-Mississippi Delta be, and it is hereby, authorized and
- 10 empowered to levy a tax upon all privileges exercised, or which
- 11 may hereafter be exercised, within the limits of the * * * levee
- 12 district, and to amend, repeal, or change the levy made by them;
- 13 but the * * * privilege taxes shall in no case exceed the taxes
- 14 levied by the state on the same privileges.
- 15 Section 2. <u>In order</u> to make the levy provided for in Section
- 16 1 of this act the Board of Levee Commissioners for the
- 17 <u>Yazoo-Mississippi Delta</u> shall enter an order upon its minutes
- 18 enumerating and designating the privileges taxed and the amount
- 19 levied thereon, a certified copy of which * * * shall be
- 20 transmitted to each tax collector within the limits of the levee
- 21 district by the secretary of <u>such</u> board; but this act shall not
- 22 affect the collection of any taxes heretofore levied and
- 23 collectible, and no action of the board shall be held to relieve
- 24 any person from the payment of any taxes collectible under
- 25 existing law.
- 26 Section 3. The tax collectors, upon the receipt of said
- 27 certified order, shall carefully preserve the same as a record in

28 their offices, and shall collect the tax so levied by the Board of
```

- 29 <u>Levee Commissioners for the Yazoo-Mississippi Delta</u> at the same
- 30 time such privileges are collected for state purposes, and no
- 31 collector shall issue a license for the state privileges without
- 32 issuing a license for the levee tax at the same time, but in case
- 33 the board shall levy a tax upon a privilege not taxed by the
- 34 state, the tax collector shall collect the amount so levied and
- 35 issue a receipt therefor, which receipt shall be dated upon the
- 36 first day of the month next preceding the date of the issuance
- 37 thereof, and shall entitle the person to whom the same may be
- 38 issued to exercise said privileges for one (1) year from said
- 39 date.
- 40 Section 4. Any person or corporation desiring to enjoy any
- 41 of the privileges levied as aforesaid, by the Board of Levee
- 42 Commissioners for the Yazoo-Mississippi Delta, shall first pay the
- 43 taxes as prescribed to the collector of taxes for the county
- 44 wherein the privilege is to be exercised, and obtain from him the
- 45 license hereinafter required; and any person or corporation who
- 46 shall exercise any of the privileges so levied without first
- 47 paying the tax and procuring the license as required shall, on
- 48 conviction, be fined not less than double the amount of the tax
- 49 imposed on such privilege, which fine, when collected, shall be
- 50 paid into the treasury of the Board of Levee Commissioners for the
- 51 Yazoo-Mississippi Delta as other collections are paid into said
- 52 treasury.
- 53 Section 5. In any case where it is inconvenient to obtain
- 54 the license from the tax collector of any county, the same may be
- obtained from the Board of Levee Commissioners for the
- 56 Yazoo-Mississippi Delta upon payment into the treasury of said
- 57 levee board, * * * the sum required for such license and ten
- 58 percent (10%) additional.
- 59 Section 6. The <u>Board of Levee Commissioners for the</u>
- 60 <u>Yazoo-Mississippi Delta</u> shall have prepared licenses for each of
- 61 the privileges so taxed by $\underline{\text{the}}$ board, and shall issue to each tax
- 62 collector in the levee district such number of * * * licenses,
- 63 signed by the secretary of the board, with the seal of his office
- 64 attached, as the collector may require for his county; and the

- 65 collector shall be charged with said licenses and shall account
- 66 for same as herein provided.
- 67 Section 7. The licenses shall be numbered consecutively for
- 68 each county, commencing with number "one," and each series shall
- 69 be for one (1) year, ending with the thirtieth day of April of
- 70 each year. Licenses granted by each collector on or after the
- 71 first day of May of each year shall be of the new series,
- 72 commencing with number "one" for the county.
- 73 Section 8. The privilege paid to the tax collector shall be
- 74 reported by him monthly, and paid into the treasury of the Board
- 75 <u>of Levee Commissioners for the Yazoo-Mississippi Delta</u> as other
- 76 taxes; and each tax collector shall, at the end of each month,
- 77 make to the <u>board</u> a detailed report of the licenses issued by him
- 78 during the month, showing the number and date of the licenses, the
- 79 name of the licensees, the privileges for which they were issued,
- 80 and the amounts collected for them; and if the collector shall
- 81 fail to make such report, he shall be liable to be punished as a
- 82 defaulter.
- 83 Section 9. The account of the <u>Board of Levee Commissioners</u>
- 84 <u>for the Yazoo-Mississippi Delta</u> against a tax collector for
- 85 licenses shall be so kept as to show by denominations and numbers
- 86 exactly what licenses charged him by the board are in his hands at
- 87 any time, and upon the final settlement of each collector, the
- 88 board shall require the return by him of all licenses charged to
- 89 him and not issued by him; and the collector shall receive credit
- 90 for all licenses he shall return to the board without having
- 91 issued them; and all licenses the collector shall not thus account
- 92 for, he shall be held liable for so much money as equals the
- 93 amount of said licenses and ten percent (10%) additional.
- 94 Section 10. Each tax collector shall make a requisition upon
- 95 the <u>Board of Levee Commissioners for the Yazoo-Mississippi Delta</u>
- 96 for so many of the licenses for privileges of the different
- 97 denominations as he will need for his county, from time to time,

- 98 which licenses, blank as to name of person and date, shall be
- 99 furnished by the board, and upon application and payment to him of
- 100 the tax imposed on any of <u>such</u> privileges, the tax collector shall
- 101 issue to the applicant for it a license, and shall date each
- 102 license the first day of the month of its issuance, and it shall
- 103 be good for one (1) year from that date * * *. The collector
- 104 shall countersign all licenses when issued by him; and he shall
- 105 keep in his office a book in which he shall enter the number of
- 106 the license, its date, the name of the licensee, the privilege
- 107 licensed, the time when the license will expire, and the amount
- 108 collected by him for it, which book shall be subject at all times
- 109 to the inspection of any officer or citizen of the district.
- 110 Anyone failing to pay the privilege tax levied as aforesaid, and
- 111 to obtain a license as herein required, but pursuing the business
- 112 taxed without such license, may be proceeded against by suit for
- 113 such tax and ten percent (10%) additional; and the tax collector
- 114 may seize and sell any property of such person liable for the tax
- in the same manner as he may distrain and sell property of other
- 116 delinquents.
- 117 Section 11. The license herein provided for shall be a
- 118 personal privilege, enjoyable only by the person to whom it is
- 119 issued, and it shall not be transferable; and such licenses shall
- 120 not exempt from taxation any property used in the business
- 121 licensed.
- 122 Section 12. This act shall take effect and be in force from
- 123 and after its passage.
- 124 SECTION 2. This act shall take effect and be in force from
- 125 and after its passage.
