SENATE BILL NO. 2768 (As Passed the Senate)

AN ACT TO STUDY THE ESTABLISHMENT OF A REGIONAL CULTURAL HERITAGE TOURISM PROGRAM WHICH SHALL BE ADMINISTERED BY THE DEPARTMENT OF ECONOMIC AND COMMUNITY DEVELOPMENT; TO PROVIDE THAT THE DEPARTMENT OF ECONOMIC AND COMMUNITY DEVELOPMENT SHALL STUDY 5 THE IMPLEMENTATION OF A REGIONAL CULTURAL HERITAGE DISTRICT IN THE 6 COUNTIES OF ADAMS, CLAIBORNE, HINDS, JEFFERSON, MADISON, RANKIN, WARREN AND WILKINSON; TO PROVIDE THAT THE DEPARTMENT OF ARCHIVES 7 8 AND HISTORY SHALL SUBMIT A PLAN REGARDING THE IMPLEMENTATION OF 9 SUCH DISTRICT TO THE LEGISLATURE WITHIN 12 MONTHS AFTER THE 10 EFFECTIVE DATE OF THIS ACT; TO PROVIDE FOR THE MEMBERSHIP OF A 11 TASK FORCE TO REVIEW THE DEVELOPMENT OF SUCH PLAN; TO GRANT THE DEPARTMENT OF ECONOMIC AND COMMUNITY DEVELOPMENT CERTAIN POWERS 12 13 WITH REGARD TO ITS DUTIES UNDER THIS ACT; TO REQUIRE THE 14 DEPARTMENT OF ECONOMIC AND COMMUNITY DEVELOPMENT TO MAKE 15 RECOMMENDATIONS WITH RESPECT TO OTHER AREAS IN THIS STATE WHERE 16 SUCH DISTRICTS WOULD BE APPROPRIATE AND VIABLE; AND FOR RELATED 17 PURPOSES. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF 18 MISSISSIPPI:

- 20 SECTION 1. (1) The purpose of this act is to enact a pilot
- 21 program to develop a regional cultural heritage tourism district
- program which shall be administered and staffed by the Department 22
- 23 of Economic and Community Development.
- (2) The regional cultural heritage tourism district pilot 2.4
- program shall include Adams, Claiborne, Hinds, Jefferson, Madison, 25
- Rankin, Warren and Wilkinson Counties. 26
- SECTION 2. Within twelve (12) months after the effective 27
- 28 date of this act, the Department of Economic and Community
- Development shall develop and submit to the Legislature a plan 29
- 30 that:
- (a) Determines the need for a regional cultural 31
- heritage tourism district that includes the counties listed in 32
- Section 1(2) of this act; 33
- (b) Specifies the goals and objectives for such 34

- 35 regional cultural heritage tourism district;
- 36 (c) Provides an inventory of the significant cultural
- 37 and historic resources in such regional cultural heritage tourism
- 38 district;
- 39 (d) Identifies legal, regulatory and other constraints
- 40 which must be overcome before meaningful cultural and historic
- 41 development can occur;
- 42 (e) Describes current and potential educational,
- 43 interpretative and recreational programs and projects concerning
- 44 such regional cultural heritage tourism district;
- 45 (f) Provides market research to document the potential
- 46 regional tourism and economic development opportunities resulting
- 47 from the development of such regional cultural heritage tourism
- 48 district;
- 49 (g) Provides an economic assessment of the long- and
- 50 short-term costs and benefits related to the implementation of the
- 51 plan, including an identification of expected sources of funding;
- 52 (h) Describes the specific cost effective techniques or
- 53 methods for the long-term preservation and documentation of the
- 54 significant cultural and historic resources in such regional
- 55 cultural heritage tourism district;
- 56 (i) Describes the public and private organizational
- 57 structure to be utilized for planning, development and management
- 58 of such regional cultural heritage tourism district; and
- 59 (j) Provides strategies and a schedule for the
- 60 planning, development and management of such regional cultural
- 61 heritage tourism district.
- 62 <u>SECTION 3.</u> For the purpose of reviewing the development of
- 63 the plan for the regional cultural heritage tourism district,
- 64 there shall be a task force that includes one (1) representative
- 65 appointed by each of the following:
- 66 (a) The boards of supervisors of Adams, Claiborne,
- 67 Hinds, Jefferson, Madison, Rankin, Warren and Wilkinson Counties;

- (b) The mayors of each municipality in the proposed
- 69 regional cultural heritage tourism district;
- 70 (c) The Executive Director of the Department of
- 71 Archives and History;
- 72 (d) The Executive Director of the Department of
- 73 Economic and Community Development;
- 74 (e) The Executive Director of the Department of
- 75 Transportation;
- 76 (f) The Executive Director of the Department of
- 77 Wildlife, Fisheries and Parks;
- 78 (g) The President of Alcorn State University;
- 79 (h) The President of Jackson State University;
- 80 (i) The Director of the Mississippi Arts Commission;
- 81 (j) The Chairman of the Mississippi River Parkway
- 82 Commission;
- 83 (k) The Regional Superintendent of the U.S. Department
- 84 of Interior, National Park Service;
- 85 (1) Other representatives as the Department of Economic
- 86 and Community Development deem appropriate.
- 87 <u>SECTION 4.</u> For purposes of this act, the Department of
- 88 Economic and Community Development shall be authorized:
- 89 (a) To advocate, coordinate, develop, plan, promote and
- 90 research cultural and historical attractions, events, properties
- 91 and services in the proposed regional cultural heritage tourism
- 92 district;
- 93 (b) To enter into such contracts and cooperative
- 94 agreements with the local, state and federal government with
- 95 agencies of such governments, with private individuals, and with
- 96 corporations, associations and other organizations, as the
- 97 department may deem necessary or convenient; and
- 98 (c) To provide grants to fund the cost of construction,
- 99 preservation, restoration, renovation, repair, investigation,
- 100 promotion or interpretation of cultural and historic attractions,

events, properties and services within the proposed regional cultural heritage tourism district.

103 SECTION 5. In addition to the duties and powers given to the 104 Department of Economic and Community Development in the foregoing 105 provisions of this act, the department shall survey cultural and 106 historical attractions, events, properties and services within 107 other identifiable geographic regions throughout this state to 108 determine other areas in which it would be viable and appropriate to establish regional cultural heritage tourism districts similar 109 110 to the pilot district authorized in this act. The department shall submit a report of its findings to the Legislature on or 111 112 before December 1, 2000, by filing a report thereon with the Secretary of the Mississippi Senate, the Clerk of the Mississippi 113 House of Representatives, the Chairman of the Senate Economic 114 Development, Tourism and Parks Committee and the Chairman of the 115 116 House Appropriations Committee.

SECTION 6. This act shall take effect and be in force from and after July 1, 1999.
