SENATE BILL NO. 2803

AN ACT TO AMEND SECTION 65-39-1, MISSISSIPPI CODE OF 1972, TO 2 INCLUDE ADDITIONAL SEGMENTS OF HIGHWAY IN COAHOMA COUNTY IN THE 3 GAMING COUNTIES STATE-ASSISTED INFRASTRUCTURE PROGRAM; AND FOR 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE RELATED PURPOSES. 5 OF MISSISSIPPI: б 7 SECTION 1. Section 65-39-1, Mississippi Code of 1972, is amended as follows: 8 65-39-1. (1) The Mississippi Transportation Commission is 9 authorized, subject to the availability of funds in the Gaming 10 11 Counties State-Assisted Infrastructure Fund created in Section 65-39-17, to conduct feasibility studies and, pursuant to 12 information gathered in such studies, select routes and locations, 13 perform preliminary engineering, acquire necessary right-of-way 14 and property, construct and/or reconstruct and improve existing or 15 new highways, roads, streets and bridges, including two-lane, 16 17 four-lane and multi-lane roads (or segments thereof), perform 18 intersection improvements, provide signal retiring, turnbay extensions, additional interchanges and other traffic 19 20 modifications, within and approaching those counties in this state 21 where legal gaming is being conducted or is authorized. Any highway, road, street or bridge that is authorized to be 22 23 constructed, reconstructed or improved shall meet design standards established by the Mississippi Department of Transportation, shall 24 25 be constructed to bear a load limit of at least eighty thousand 26 (80,000) pounds and, upon completion, shall become a part of the 27 state highway system, and thereafter shall be under the jurisdiction of the Mississippi Transportation Commission and the 28

- 29 Mississippi Department of Transportation for construction and
- 30 maintenance.
- 31 (2) The projects authorized in subsection (1) of this
- 32 section shall include, but shall not be limited to, highways,
- 33 roads, streets and bridges on and along the following locations:
- 34 (a) U.S. Highway 90 from its intersection with
- 35 Mississippi 607 in Hancock County to Ocean Springs, and including
- 36 Lakeshore Road in Hancock County from its intersection with U.S.
- 37 Highway 90 to Beach Boulevard;
- 38 (b) Mississippi 4 from U.S. Highway 61 to Mississippi
- 39 3;
- 40 (c) Mississippi 4 from Mississippi 3 to Senatobia;
- 41 (d) Lorraine/Cowan Road from U.S. Highway 90 to I-10;
- 42 (e) U.S. Highway 49 from U.S. Highway 90 to I-10 in
- 43 Gulfport;
- 44 (f) Mississippi 304 beginning at the Tennessee State
- 45 Line at or near U.S. 72 and thence running in a southwesterly
- 46 direction to intersect with U.S. 78 at or near Byhalia and thence
- 47 running in a westerly direction to intersect I-55 at or near
- 48 Hernando and thence running in a westerly direction to intersect
- 49 with U.S. 61 in DeSoto County, with a spur extending southwesterly
- 50 to or near Robinsonville in Tunica County;
- 51 (g) I-10 from Exit 28 to Exit 57;
- 52 (h) A new location from the northernmost point on I-110
- 53 to U.S. 49;
- 54 (i) U.S. Highway 61 from the Tunica County line to the
- 55 Tennessee state line;
- (j) (i) Four-lanes for traffic along Mississippi 16
- 57 beginning at its intersection with Mississippi 25 and extending
- 58 easterly to join the existing four-lane on the west side of
- 59 Carthage within the corporate boundaries;
- (ii) Passing lanes and turn lanes, as needed,
- 61 along Mississippi 16 beginning at a point on the east side of
- 62 Carthage within the corporate boundaries where the existing
- 63 four-lane ends and extending easterly to the Leake/Neshoba County
- 64 line; and
- 65 (iii) Four-lanes for traffic along Mississippi 16

- 66 beginning at the Leake/Neshoba County line and extending easterly
- 67 to not more than ten (10) miles east of Mississippi 15;
- 68 (k) Lorraine/Cowan Road Extension from I-10 North to
- 69 relocated/reconstructed Mississippi 67;
- 70 (1) At various locations on and along U.S. Highway 82
- 71 and Mississippi 1 in the City of Greenville;
- 72 (m) At various locations on and along I-20, U.S.
- 73 Highway 61 and U.S. Highway 80 in the City of Vicksburg, including
- 74 a truck route from Harbor Industrial Park to U.S. Highway 61 north
- 75 and an extension of South Frontage Road with railroad bridge to
- 76 Interstate Highway 20;
- 77 (n) At various locations on and along U.S. Highway 61,
- 78 U.S. Highway 65 and Washington Street in the City of Natchez;
- 79 (o) At various locations on and along U.S. Highway 90
- 80 in the City of Pass Christian;
- 81 (p) Mississippi 43/603 beginning where the existing
- 82 four-lane ends north of I-10 and extending northerly to a point
- 83 approximately one (1) mile north of Kiln where Mississippi 43/603
- 84 divides into Mississippi 43 and Mississippi 603;
- 85 (q) Mississippi 43 beginning where Mississippi 43 and
- 86 Mississippi 603 divide and extending northwesterly to or near
- 87 Picayune;
- 88 (r) U.S. 49 from U.S. 61 west to the Mississippi River
- 89 bridge;
- 90 (s) Subject to the conditions prescribed in subsection
- 91 (3) of this section, a central Harrison County connector from I-10
- 92 to U.S. 90 in the vicinity of Canal Road to the Mississippi State
- 93 Port at Gulfport; * * *
- 94 (t) An east Harrison County connector from U.S. 90 to
- 95 I-10 to be located between the Cowan-Lorraine Road interchange and
- 96 the I-110 interchange;
- 97 (u) U.S. Highway 49 from Clarksdale to Dublin; and
- 98 <u>(v) Mississippi 6 from U.S. Highway 61 to the</u>

- 99 Quitman-Panola County Line.
- 100 (3) Authorization for the project described in paragraph
- 101 (2)(s) of this section is conditioned upon receipt by the
- 102 Mississippi Transportation Commission of a written commitment by
- 103 the Department of Economic and Community Development to make
- 104 available for such project not less than Six Million Dollars
- 105 (\$6,000,000.00).
- 106 (4) All planning, construction, reconstruction and
- 107 performance of the projects authorized under this section,
- 108 including the letting of contracts, shall commence, proceed and be
- 109 performed by the Mississippi Transportation Commission and the
- 110 Mississippi Department of Transportation according to priorities
- 111 based on volume capacity and traffic congestion in comparative
- 112 project areas; however, if a project authorized in this section is
- 113 also included in the four-lane highway program under Section
- 114 65-3-97, then all contracts necessary to be let for the completion
- 115 of the project under this section shall be let not later than the
- 116 priorities established for the letting of contracts for the
- 117 project under Section 65-3-97.
- 118 (5) (a) Funds for the projects authorized under this
- 119 section may be provided through the issuance of bonds under
- 120 Sections 65-39-5 through 65-39-33, through the issuance of notes
- 121 for such purposes under Section 31-17-127 or from such monies as
- 122 may be available in the Gaming Counties State-Assisted
- 123 Infrastructure Fund created under Section 65-39-17.
- 124 (b) In addition to the funds provided for under
- 125 paragraph (a) of this subsection, funds for the project described
- in subsection (2)(s) of this section also may be provided from any
- 127 available federal, state, county or municipal funds authorized for
- 128 such project, including the Economic Development Highway Act.
- 129 SECTION 2. This act shall take effect and be in force from
- 130 and after July 1, 1999.
