SENATE BILL NO. 2837

1 AN ACT TO AMEND SECTION 19-25-13, MISSISSIPPI CODE OF 1972, 2 TO REVISE THE HIRING OF CERTAIN EMPLOYEES OF SHERIFFS; AND FOR 3 RELATED PURPOSES. 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 5 SECTION 1. Section 19-25-13, Mississippi Code of 1972, is 6 amended as follows: 7 19-25-13. The sheriff shall, at the July meeting of the board of supervisors, submit a budget of estimated expenses of his 8 9 office for the ensuing fiscal year beginning October 1 in such form as shall be prescribed by the Director of the State 10 Department of Audit. The board shall examine this proposed budget 11 12 and determine the amount to be expended by the sheriff in the 13 performance of his duties for the fiscal year and may increase or reduce said amount as it deems necessary and proper. 14 The budget shall include amounts for compensating the 15 deputies and other employees of the sheriff's office, for 16 insurance providing protection for the sheriff and his deputies in 17 case of disability, death and other similar coverage, for travel 18 and transportation expenses of the sheriff and deputies, for 19 20 feeding prisoners and inmates of the county jail, and for such other expenses as may be incurred in the performance of the duties 2.1 of the office of sheriff. In addition, the budget shall include 22 amounts for the payment of premiums on bonds and insurance for the 23 sheriff and his deputies which, in the opinion of the board of 24 25 supervisors, are deemed necessary to protect the interests of the

county or the sheriff and his deputies. Such amounts may include

official bonds and any bonds required of his deputies by the 28 sheriff; liability insurance; insurance against false arrest charges; insurance against false imprisonment charges; theft, fire 29 and other hazards insurance; and hospitalization insurance as 30 31 provided for in Sections 25-15-101 and 25-15-103. The board may 32 authorize the reimbursement of the sheriff and deputies for the use of privately owned automobiles or other motor vehicles in the 33 34 performance of official duties at the rate provided by law for state officers and employees or may authorize the purchase by the 35 sheriff of such motor vehicles and such equipment as may be needed 36 for operation of the sheriff's office, such vehicles and equipment 37 to be owned by the county. In counties which have elected to 38 39 purchase the motor vehicles and such equipment for the operation of the sheriff's office, if a sheriff or deputy shall be required 40 in the performance of his official duties, in the event of an 41 emergency, to use his privately owned automobile or other motor 42 vehicle, the board of supervisors may, in its discretion, 43 44 authorize the reimbursement for such use at the rate per mile provided by law for state officers and employees. 45 This shall not 46 be construed as giving an officer a choice of whether to use his 47 own or the county's vehicle but shall be construed so as not to 48 penalize an officer who must use his own vehicle because the county's vehicle was not available. 49 50 The board of supervisors may acquire one or more credit cards 51 which may be used by the sheriff and his deputies to pay expenses incurred by them when traveling in or out of state in the 52 53 performance of their official duties. The chancery clerk or county purchase clerk shall maintain complete records of all 54 55 credit card numbers and all receipts and other documents relating 56 to the use of such credit cards. The sheriff shall furnish 57 receipts for the use of such credit cards each month to the 58 chancery clerk or purchase clerk who shall submit a written report monthly to the board of supervisors, which report shall include an 59 60 itemized list of all expenditures and use of the credit cards for 61 the month, and such expenditures may be allowed for payment by the 62 county in the same manner as other items on the claims docket. The issuance of a credit card to a sheriff or his deputy under the 63

64 provisions of this section shall not be construed to authorize

65 such sheriff or deputy sheriff to use such credit card to make any

- 66 expenditure which is not otherwise authorized by law.
- The board of supervisors is hereby authorized and empowered,
- 68 in its discretion, to appropriate and pay a sum not to exceed Four
- 69 Hundred Dollars (\$400.00) annually as a clothing allowance to each
- 70 plainclothes investigator employed by the sheriff's office of such
- 71 county. The board of supervisors of any county bordering on the
- 72 Gulf of Mexico and having a population of more than thirty-one
- 73 thousand seven hundred (31,700) but less than thirty-one thousand
- 74 eight hundred (31,800) according to the 1990 Federal Census may
- 75 appropriate and pay a sum not to exceed Four Hundred Dollars
- 76 (\$400.00) annually as a clothing allowance to the administrator of
- 77 the county jail.
- 78 The sheriff is hereby authorized and empowered, in his
- 79 discretion, to delegate to the board of supervisors the
- 80 responsibility and authority to employ and set the salary of not
- 81 more than one (1) employee for the office of the sheriff, such
- 82 salary to be paid as other expenditures are paid from the funds
- 83 provided by this section. Such employee shall be deemed to be
- 84 appointed and employed by the board of supervisors and the salary
- 85 shall not be deemed to be a pecuniary benefit provided by the
- 86 sheriff.
- The board of supervisors shall, at its first meeting of each
- 88 quarter beginning on October 1, January 1, April 1 and July 1,
- 89 appropriate a lump sum for the sheriff for the expenses of his
- 90 office during the current quarter. The quarterly appropriation
- 91 shall be one-fourth (1/4) of the amount approved in the annual
- 92 budget unless the sheriff requests a different amount. Except in
- 93 case of emergency, as provided in the county budget law, the
- 94 appropriation for the quarter beginning in October of the last
- 95 year of the sheriff's term shall not exceed one-fourth (1/4) of
- 96 the annual budget.

97 The sheriff shall file a report of all expenses of his office incurred during the preceding month with the board of supervisors 98 99 for approval at its regular monthly meeting in a form to be prescribed by the Director of the State Department of Audit, and 100 101 upon filing thereof, and approval by the board, the clerk of the 102 board shall issue warrants in payment thereof but not to exceed 103 the budget appropriation for that quarter. Any appropriated funds 104 which are unexpended at the end of the fiscal year shall remain in

The budget for the sheriff's office may be revised at any regular meeting by the board of supervisors. Upon recommendation of the sheriff, the board may at any regular meeting make supplemental appropriations to the sheriff's office.

Any fees previously required to be paid by a sheriff shall be paid by the board of supervisors by including the estimates therefor in the sheriff's budget. All fees and charges for services heretofore collected by sheriffs shall be collected by said sheriff and paid monthly into the general fund of the concerned county. However, any fees heretofore collected by such sheriffs from the county shall not be paid.
