SENATE BILL NO. 2878

1 AN ACT TO PROVIDE FOR THE ISSUANCE OF A SPECIAL MOTOR VEHICLE 2 LICENSE TAG DISPLAYING AN EMBLEM DESIGNED BY THE MISSISSIPPI 3 COMMISSION FOR VOLUNTEER SERVICES; TO PROVIDE THAT A PORTION OF 4 THE ADDITIONAL FEE COLLECTED ON SUCH SPECIAL LICENSE TAGS SHALL BE 5 DEPOSITED INTO THE MISSISSIPPI COMMISSION FOR VOLUNTEER SERVICE 6 FUNDS; AND FOR RELATED PURPOSES.

7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: SECTION 1. (1) Owners of motor vehicles upon complying with 8 9 the motor vehicle laws relating to registration and licensing of motor vehicles, and upon payment of the road and bridge privilege 10 11 taxes, ad valorem taxes and registration fees as prescribed by law for private carriers of passengers, pickup trucks and other 12 noncommercial motor vehicles, and upon payment of an additional 13 14 annual fee in the amount of Thirty Dollars (\$30.00), shall be issued a special license tag which displays an emblem designed by 15 the Mississippi Commission for Volunteer Service. 16

17 (2) The Mississippi Commission for Volunteer Service shall 18 design emblems which shall be displayed on the special license 19 tag. The emblem shall be affixed during the production of the 20 license tag.

21 (3) Application for the special license tags shall be made to the county tax collector on forms prescribed by the State Tax 22 23 Commission. The application and the additional fee, less five percent (5%) thereof to be retained by the tax collector, shall be 24 25 remitted to the State Tax Commission within seven (7) days of the 26 date the application is made. The portion of the additional fee 27 retained by the tax collector shall be deposited into the county general fund. 28

period. The additional annual fee shall be due and payable at the
time of renewal registration.

32 (5) The State Tax Commission shall deposit all fees into the 33 State Treasury on the day received. At the end of each month, the 34 State Tax Commission shall certify the total fees collected under 35 this section to the State Treasurer who shall distribute such 36 collections as follows:

37 (a) Twenty Dollars (\$20.00) of each additional fee
38 collected on special license tags issued pursuant to this section
39 shall be deposited into the Mississippi Commission for Volunteer
40 Service Fund created pursuant to Section 27-7-90.

(b) The remainder of each such additional fee shall be
deposited to the credit of the State Highway Fund to be expended
solely for the repair, maintenance, construction or reconstruction
of highways.
