- 7 SECTION 1. Section 49-7-51, Mississippi Code of 1972, is
- 8 amended as follows:
- 9 49-7-51. (1) It is unlawful for any person to buy or sell
- 10 or to offer for sale, exchange for merchandise, or other
- 11 consideration, within this state, any game birds, game animals, or
- 12 game fish, or parts thereof, named in this chapter, whether taken
- 13 within or coming from without the state, except as specifically
- 14 permitted by law or regulation. * * * The skins and sinew of deer
- 15 may be bought and sold at any time.
- 16 (2) Any person who buys, sells, offers for sale, exchange
- 17 for merchandise, or other consideration, any wild bird, wild
- 18 <u>animal or fish that has been taken illegally is guilty of a Class</u>
- 19 <u>I violation and punished as provided in Section 49-7-141.</u>
- 20 (3) Any purchase, sale, offer for sale, exchange for
- 21 merchandise, or other consideration of such animals, birds or
- 22 fish, that has a value of Three Hundred Dollars (\$300.00) or more
- 23 shall be a felony, and any such person or persons committing such
- 24 <u>felony shall be subject to a fine of not less than Two Thousand</u>
- 25 <u>Dollars (\$2,000.00) nor more than Five Thousand Dollars</u>
- 26 (\$5,000.00) or may be imprisoned for a term not to exceed one (1)
- 27 <u>year, or both. Any</u> violation of this section <u>of less than Three</u>

- 28 <u>Hundred Dollars (\$300.00) in value</u> is a Class I violation and is
- 29 punishable as provided in Section 49-7-141.
