SENATE BILL NO. 3039

1 AN ACT TO AMEND SECTION 37-13-89, MISSISSIPPI CODE OF 1972, 2 TO PROVIDE THAT ANY UNUSED LEAVE CREDITED TO SCHOOL ATTENDANCE 3 OFFICERS WHEN THEY WERE EMPLOYED BY DISTRICT ATTORNEYS SHALL BE 4 CARRIED OVER AND CREDITED TO SUCH PERSONS IF THEY REMAINED 5 EMPLOYED BY THE STATE DEPARTMENT OF EDUCATION, AND TO REVISE THE 6 STATUTORY SCALE FOR SCHOOL ATTENDANCE OFFICERS EMPLOYED BY THE 7 STATE DEPARTMENT OF EDUCATION; AND FOR RELATED PURPOSES.

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 9 SECTION 1. Section 37-13-89, Mississippi Code of 1972, is 10 amended as follows:

37-13-89. (1) In each school district within the state, 11 there shall be employed the number of school attendance officers 12 determined by the Office of Compulsory School Attendance 13 14 Enforcement to be necessary to adequately enforce the provisions 15 of the Mississippi Compulsory School Attendance Law; however, this number shall not exceed one hundred fifty-three (153) school 16 17 attendance officers at any time. From and after July 1, 1998, all school attendance officers employed pursuant to this section shall 18 be employees of the State Department of Education. The State 19 Department of Education shall employ all persons employed as 20 school attendance officers by district attorneys before July 1, 21 22 1998, and shall assign them to school attendance responsibilities in the school district in which they were employed before July 1, 23 24 1998. The first twelve (12) months of employment for each school attendance officer shall be the probationary period of state 25 service. Any unused leave credited to such school attendance 26 officers when they were employed by district attorneys shall be 27 carried over and credited to such persons if they remain employed 28 29 as school attendance officers by the State Department of

31 (2) Each school attendance officer shall possess a college degree with a major in a behavioral science or a related field or 32 33 shall have no less than three (3) years combined actual experience 34 as a school teacher, school administrator, law enforcement officer possessing such degree, and/or social worker; however, these 35 requirements shall not apply to persons employed as school 36 attendance officers before January 1, 1987. School attendance 37 officers also shall satisfy any additional requirements that may 38 be established by the State Personnel Board for the position of 39 school attendance officer. 40

41 (3) It shall be the duty of each school attendance officer42 to:

43 (a) Cooperate with any public agency to locate and
44 identify all compulsory-school-age children who are not attending
45 school;

46 (b) Cooperate with all courts of competent47 jurisdiction;

48 (c) Investigate all cases of nonattendance and unlawful 49 absences by compulsory-school-age children not enrolled in a 50 nonpublic school;

51 (d) Provide appropriate counseling to encourage all 52 school-age children to attend school until they have completed 53 high school;

(e) Attempt to secure the provision of social or
welfare services that may be required to enable any child to
attend school;

(f) Contact the home or place of residence of a compulsory-school-age child and any other place in which the officer is likely to find any compulsory-school-age child when the child is absent from school during school hours without a valid written excuse from school officials, and when the child is found, the officer shall notify the parents and school officials as to where the child was physically located;

64 (g) Contact promptly the home of each 65 compulsory-school-age child in the school district within the 66 officer's jurisdiction who is not enrolled in school or is not in 67 attendance at public school and is without a valid written excuse S. No. 3039 99\SS01\R1187 PAGE 2 68 from school officials; if no valid reason is found for the 69 nonenrollment or absence from the school, the school attendance 70 officer shall give written notice to the parent, guardian or 71 custodian of the requirement for the child's enrollment or 72 attendance;

(h) Collect and maintain information concerning absenteeism, dropouts and other attendance-related problems, as may be required by law or the Office of Compulsory School Attendance Enforcement; and

77 (i) Perform all other duties relating to compulsory
78 school attendance established by the State Department of Education
79 or district school attendance supervisor, or both.

80 (4) While engaged in the performance of his duties, each school attendance officer shall carry on his person a badge 81 identifying him as a school attendance officer under the Office of 82 83 Compulsory School Attendance Enforcement of the State Department 84 of Education and an identification card designed by the State Superintendent of Public Education and issued by the school 85 attendance officer supervisor. Neither the badge nor the 86 identification card shall bear the name of any elected public 87 88 official.

89 (5) <u>From and after July 1, 1999</u>, the salary scale for school 90 attendance officers shall be as follows:

91 (a) For school attendance officers holding a bachelor's 92 degree or any other attendance officer who does not hold such a 93 degree, the annual salary shall be based on years of experience as 94 a school attendance officer or related field of service or
