## SENATE BILL NO. 3133

1 2	AN ACT MAKING AN APPROPRIATION TO DEFRAY THE EXPENSES OF THE STATE TREASURER'S OFFICE FOR FISCAL YEAR 2000.
3	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
4	SECTION 1. The following sum of money, or so much thereof as
5	may be necessary, is hereby appropriated out of any money in the
6	State General Fund not otherwise appropriated, to defray the
7	expenses of the office of the State Treasurer for the fiscal year
8	beginning July 1, 1999 and ending June 30, 2000
9	\$ 753,585.00.
10	SECTION 2. The following sum, or so much thereof as may be
11	necessary, is hereby appropriated out of any funds in the special
12	fund entitled Abandoned Property Fund in the State Treasury for
13	the purpose of defraying expenses of the State Treasurer in
14	administering the Uniform Disposition of Unclaimed Property and
15	certain other expenses of the office, for the fiscal year
16	beginning July 1, 1999, and ending June 30, 2000
17	\$ 1,835,775.00.
18	SECTION 3. Of the funds appropriated under the provisions of
19	Sections 1 and 2, not more than the amounts set forth below shall
20	be expended for the respective major objects or purposes of
21	expenditure:

42	SECTION 4. From the funds provided in this act, funds may be
43	expended for the following purposes: The State Treasurer may
44	invest up to one-half of the monies of the tobacco settlement in
45	any of the investments authorized for the Mississippi Prepaid
46	Affordable College Tuition Program under Section 37-155-9, and
47	such investments shall be subject to the limitations prescribed by
48	Section 37-155-9. For purposes of this section, "tobacco
49	settlement" means the settlement of the case of Mike Moore,
50	Attorney General ex rel. State of Mississippi v. The American
51	Tobacco Company et al. (Chancery Court of Jackson County,
52	Mississippi, Cause No. 94-1429) and the settlement of any case
53	brought against tobacco companies by another state.
54	SECTION 5. In addition to all other sums herein
55	appropriated, the following sum, or so much thereof as may be
56	necessary, is hereby appropriated out of any money in the State
57	Treasury to the credit of the Education Improvement Trust Fund No.
58	3219 for the purpose of investing funds for the fiscal year
59	beginning July 1, 1999, and ending June 30, 2000

60	\$ 87,000.00.
61	SECTION 6. The following sum, or so much thereof as may be
62	necessary, is hereby appropriated out of any money in the State
63	Treasury to the credit of the Mississippi Prepaid Affordable
64	College Tuition Administrative Fund to defray the costs of the
65	Mississippi Prepaid Affordable College Tuition Program for the
66	fiscal year beginning July 1, 1999, and ending June 30, 2000
67	\$ 2,100,839.00.
68	With the funds appropriated in this section, the following
69	positions are authorized:
70	AUTHORIZED POSITIONS:
71	Permanent: Full Time 5
72	SECTION 7. From the funds provided in this act, funds may be
73	expended for the following purposes, in compliance with the
74	policies established by the State Personnel Board and any
75	conditions placed on such expenditures:
76	(a) The components of the Variable Compensation Plan
77	shall be maintained within the constraints of the funds
78	appropriated herein.
79	(b) Funds are provided to adjust the Variable
80	Compensation Plan, including realignment, to ensure that all
81	full-time employees with at least six (6) months of continuous
82	current service, as of June 30, 1999, receive an increase of One
83	Thousand Five Hundred Dollars (\$1,500.00). Funds are provided to
84	adjust critical job classes up to an additional One Thousand
85	Dollars (\$1,000.00).
86	(c) If an employee is currently at or above the end
87	salary for his or her job classification, then the increase shall
88	be built into the employee's base salary. To be eligible for any
89	increase authorized in this section, employees may not have a
90	current performance rating below "meets expectations" as of the
91	effective date of the increase. Employees who subsequently

receive a performance rating of "meets expectations" or above

- 93 during Fiscal Year 2000 shall receive the salary increase
- 94 effective the date of the rating.
- 95 It is the agency's responsibility to make certain that funds
- 96 required to be appropriated for "Personal Services" for Fiscal
- 97 Year 2001 do not exceed Fiscal Year 2000 funds appropriated for
- 98 that purpose unless programs or positions are added to the
- 99 agency's budget by the Mississippi Legislature.
- 100 SECTION 8. It is the intention of the Legislature that the
- 101 State Treasurer is hereby authorized to accept, budget and expend
- 102 an amount not to exceed Five Hundred Thousand Dollars
- 103 (\$500,000.00) from administrative fees charged for the
- 104 administration of the Mississippi Prepaid Affordable College
- 105 Tuition Program and deposited in the Mississippi Prepaid
- 106 Affordable College Tuition Administrative Fund. Such funds shall
- 107 be escalated in accordance with the rules and regulations of the
- 108 Department of Finance and Administration in a manner consistent
- 109 with the escalation of federal funds.
- 110 SECTION 9. It is the intention of the Legislature that the
- 111 State Treasurer is hereby authorized to accept, budget and expend
- 112 funds for the purpose of defraying the cost of administering the
- 113 Mississippi Prepaid Affordable College Tuition Program in an
- amount not to exceed Five Hundred Thousand Dollars (\$500,000.00)
- 115 which become available from interest earnings on any funds
- 116 authorized for administration of said program. Such funds shall
- 117 be escalated in accordance with the rules and regulations of the
- 118 Department of Finance and Administration in a manner consistent
- 119 with the escalation of federal funds.
- 120 SECTION 10. In addition to all other sums herein
- 121 appropriated, the following sum, or so much thereof as may be
- 122 necessary, is hereby appropriated out of any money in the State
- 123 Treasury to the credit of the Mississippi Prepaid Affordable
- 124 College Tuition Trust Fund for the purpose of paying all amounts
- 125 due for prepaid tuition contracts of the Mississippi Prepaid

- 128 SECTION 11. No part of the funds appropriated herein shall
- 129 be used in the payment of attorney's fees, nor shall any of said
- 130 funds be used either directly or indirectly, for the purpose of
- 131 paying any clerk, stenographer, assistant, deputy or other person
- 132 who may be related by blood or marriage within the third degree,
- 133 computed by the rules of the civil law, to the official employing
- 134 or having the right of employment or selection thereof; and in the
- 135 event of any such payment, then the official or person approving
- 136 and making or receiving such payment shall be jointly and
- 137 severally liable to return to the State of Mississippi and to pay
- 138 into the State Treasury three (3) times any such amount so paid or
- 139 received, to be recovered at suit of the Attorney General;
- 140 provided that when the relationship is by affinity and the person
- 141 through whom the relationship was established is dead, this

- 143 SECTION 12. Of the funds appropriated under the provisions
- 144 of Sections 1 and 2, and authorized for expenditure in Section 3,
- 145 funds in the amount of Fourteen Thousand One Hundred Dollars
- 146 (\$14,100.00) are included to defray the annualized costs of agency
- 147 specific realignments or reallocations for three (3) positions
- 148 within the State Treasurer's Office.
- 149 The realignments or reallocations referenced within this
- 150 section are applicable only to the State Treasurer's Office and
- 151 said salary adjustments shall not be construed to apply to any
- 152 other positions under the purview of the State Personnel Board.
- 153 SECTION 13. Of the funds appropriated under the provisions
- 154 of Section 6, funds in the amount of One Thousand Nine Hundred
- 155 Dollars (\$1,900.00) are included to defray the annualized cost of
- 156 an agency specific realignment or reallocation for one (1)
- 157 position within the State Treasurer's Office.
- 158 The realignment or reallocation referenced within this

159 section are applicable only to the State Treasurer's Office and said salary adjustment shall not be construed to apply to any 160 161 other positions under the purview of the State Personnel Board. 162 SECTION 14. The money herein appropriated shall be paid by the State Treasurer out of any money in the State Treasury to the 163 164 credit of the proper fund or funds as set forth in this act, upon warrants issued by the State Fiscal Officer; and the State Fiscal 165 166 Officer shall issue his warrants upon requisitions signed by the proper person, officer or officers in the manner provided by law. 167 SECTION 15. This act shall take effect and be in force from 168 169 and after July 1, 1999.
